Fiscal Year 2024 Mission Bay Park Improvement Funds – Ryan Barbrick, Supervising Management Analyst, Parks and Recreation Department requested the Mission Bay Park Improvement Fund Oversight Committee approve the recommendation to allocate \$7,150,000 of Mission Bay Park Improvement Funds to the following projects: Dusty Rhodes Comfort Station, CIP# B19180, \$1,000,000; El Carmel Comfort Station, CIP# B18226, \$489,243; South De Anza Comfort Station (formerly Playa Pacifica Comfort Station), CIP# B19172, \$936,234; South De Anza Playground (formerly Playa Pacifica Playground), CIP# B19173, \$3,308,000; and Robb Field Gateway Path, CIP# B19157, \$1,416,523
