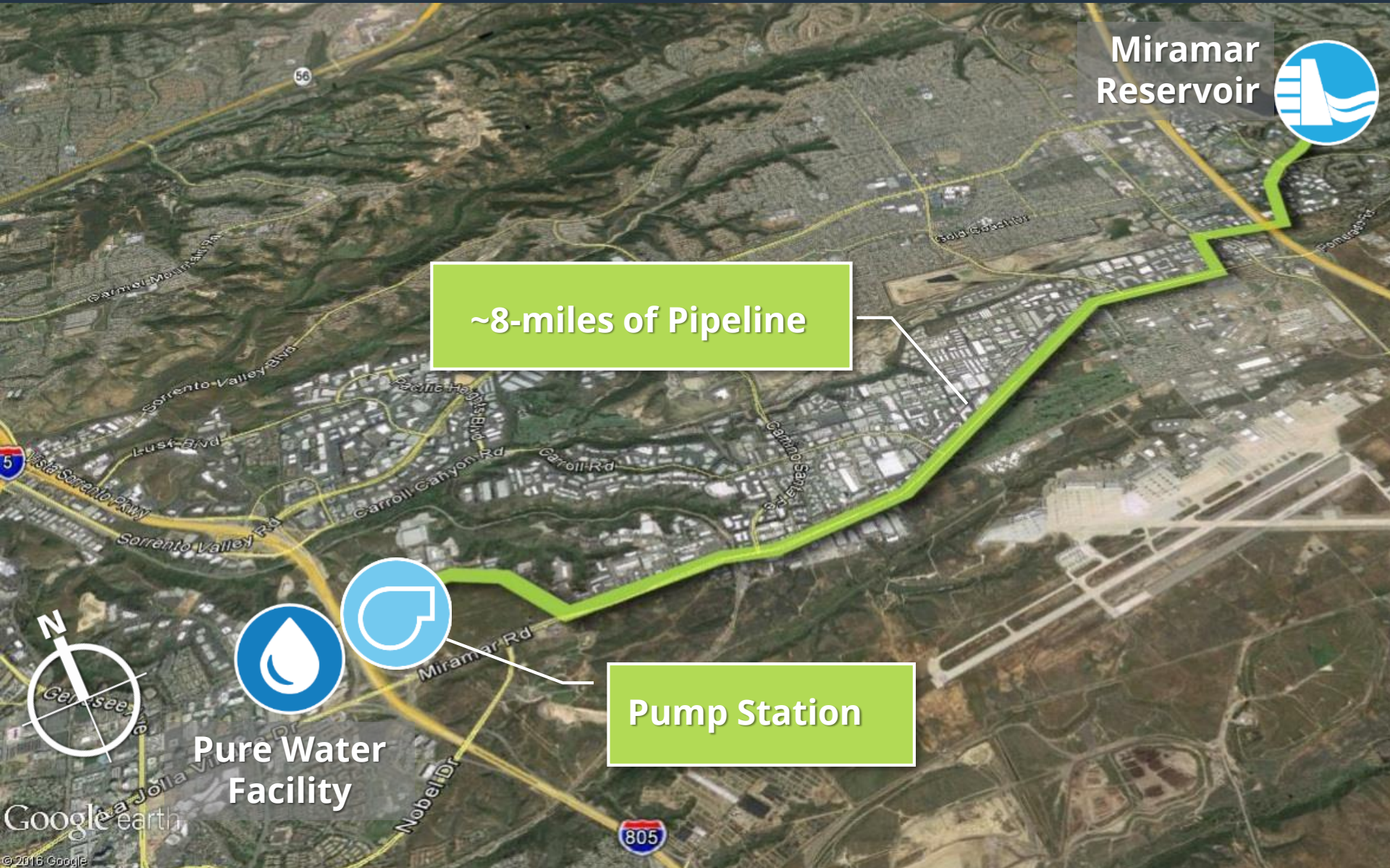

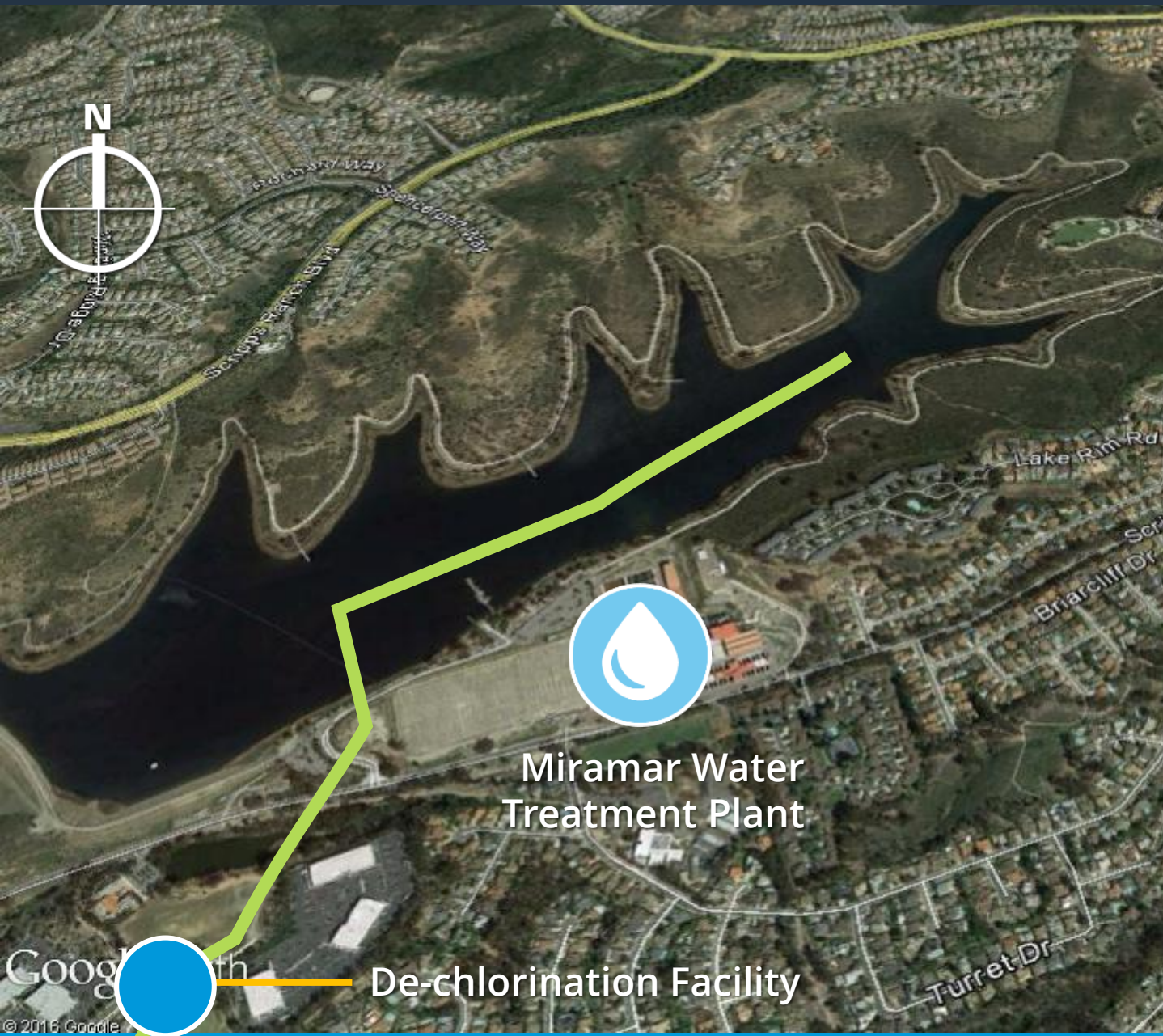
North City Pure Water Pipeline Schedule



- Bid Advertised: February 2019
- Notice to Proceed: July 2019
- Substantial Construction Completion: Fall 2022
- Commissioning: 2023



Pure Water Subaqueous Pipeline Schedule



- Bid Advertised: March 2020
- Notice to Proceed: September 2020
- Substantial Construction Completion: Spring 2021
- Commissioning: 2023
