SUBJECT:	Request to Pay Legal Fees from Auditor's Budget

I know we have discussed this issue in the past and appreciate your patience in listening to my efforts in resolving this matter. In connection with an inquiry initiated by the Sanders Administration started while the Auditor's office was conducting an audit of the Development Services Department, the Auditor was required to retain counsel to defend the Auditor's office's independence. When the inquiry conducted by outside legal counsel showed the Auditor's office had acted in conformity with its duties, the Sanders Administration retained a second law firm to determine whether the Auditor's office had engaged in some form of retaliation. The second inquiry found there was no retaliation. Again, the Auditor was required to retain legal counsel to defend the Auditor's office. The Auditor's retention was required because the inquiries implicated directly the central duty of the Auditor to retain independence, the inquiries were carried out by legal counsel, and the City Attorney was unable to represent the Auditor's office because of conflicting duties.

Upon these premises it appears to me that the legal fees incurred should be paid by the City. The Auditor proposes to pay those legal fees from the Auditor's budget. However, before do doing I am asking you to place the proposal that the legal fees incurred in connection with both inquiries be paid from the Auditor's budget on the Council Agenda for approval at the first opportunity.

Please let me know if this request meets with your approval.

Dear Mr. Luna:

Claims against the City of San Diego are referred to this office for investigation, and with the advice of the office of the City Attorney a determination of legal liability.

As you may know, the liability of a municipality to persons who claim damages is strictly limited by the legislature of the State of California governing municipal operations. We must review the circumstances of your claim within the terms of those laws. We regret that investigation and legal opinion oblige us to conclude that the City must deny your claim.

Subject to certain exceptions, you have only six (6) months from the date this notice was personally delivered or deposited in the mail to file a court action on this claim. See Government Code Section 945.6.

You may seek the advice of an attorney of your choice in connection with this matter. If you desire to consult an attorney, you should do so immediately.
