# ITEM #1 Call to Order/Roll Call:

Chair, Robin Kaufman called the meeting to order at 7:00pm. She noted that the meeting is being recorded for accuracy in the meeting minutes, and noted that it is being conducted as if it were in in-person and that participants should extend all courtesies as such.

# ITEM #7 <u>Councilmember Marni Von Wilpert (Information Item):</u>

# (Item out of order per agenda to accommodate visitors)

<u>Councilmember Marni von Wilpert</u> discussed a range of topics for District 5 followed by a Q&A period. Topics included the recent passing of the city budget, including substantial increases to infrastructure improvements; ineffective street preservation ordinances; a new police unit for drag racing enforcement; Rancho Bernardo park improvements; and on-going emergency repairs at Lake Hodges (below the waterline). The Councilwoman also commented on the upcoming Comic-Con in San Diego, noted that the council's recent update on the Climate Action Plan (2.0), highlighted recent legislation that bans flavored tobacco products, and noted the first conviction resulting from the "ghost gun" legislation aimed to counter non-serialized firearms across San Diego. The City Council is about to go into legislative recess.

Kathleen Lippitt commented on the lack of accountability for prospective marijuana outlet applicants that do not adhere to application processes such as residential notifications and lack of community board engagement.

Becky Rapp asked about what the city council can do to buttress and enforce municipal marijuana outlet applications' transparency and regulation.

Hugh Rothman asked about counter-homelessness initiatives across San Diego. The Councilwomen commented on her continued support for homeless conservatorships, shelters where common underlying behavioral health and substance abuse issues can be addressed.

Benjamin Wier asked the Councilwomen and staff to look into the current marijuana outlet being proposed at 16375 Bernardo Center Drive (formerly the El Torito restaurant) and the lack of adherence to property-line controls.

Steve Dow asked about wildfire control and brush maintenance programs and policies.

Sonny Googins thanked both Becky Rapp and Councilwomen Marni von Wilpert for their enthusiasm for public service.

Joni Edelman voiced her concern about the city's lack of adherence regarding the 100' set-back for potential marijuana outlets from residential spaces.

Hugh Rothman asked the Councilwomen to look into the traffic signal update at the corner of Rancho Bernardo Road West Bernardo Drive.

Victoria LaBruzzo and Robin Kaufman voiced their concerns to the Councilwomen about the proposed amendments to planning group membership policies and how the changes may disincentivize participation and generally negatively affect communities across District 5. The Councilwoman is looking forward to hearing additional feedback at an upcoming all-Chairs meeting.

# ITEM #3 Non-agenda public comment (3 minutes per speaker):

Becky Rapp voiced her concern about cannabis outlet allocation in the RB area, particularly the on-going license application at the location at 16375 Bernardo Center Drive (formerly the El Torito restaurant) in which this active application entails a site that directly borders a residential property line.

# ITEM #4 Government Staff Reports (Information Item):

<u>Emily Piatanesi</u>, Community Representative for Council Districts 5 and 7, introduced herself and provided updates on behalf of Mayor Gloria from District 5 on the new San Diego budget and commented on counter-homelessness strategies.

Diana Lara from State Senator Toni Atkins provided updates including the recent recognition of the non-profit <u>Zero8Hundred</u> Military Transition Assistance.

# ITEM #5 Modification and Adoption of Agenda (Voting Item):

Benjamin Wier motioned to approve the agenda; Sonny Googins seconded; motion approved 12-0-0. In addition, the agenda was noted for an errant Traffic & Transportation chair (corrected in the Meeting Minutes).

# ITEM #6 Administrative Items (Voting Item):

Approval of April 2022 Board Meeting Minutes was motioned by Sonny Googins; seconded by Benjamin Wier; motion was approved 8-0-4 (abstentions by Robin Kaufman due to absence at April 2022 board meeting; Donald Bertsch, David Wilson, and Patrick Batten due to not being seated board members at the time of April 2022 board meeting).

Approval of the May 2022 Board Meeting Minutes was motioned by Sonny Googins; seconded by Owen Nucci; motion passed 10-0-2 (abstentions by Vicki Touchstone and Hugh Rothman due to absence at the May 2022 Board Meeting).

Robin Kaufman covered the Treasurer's Report in the absence of Gary Long. The Board has \$322.95 in the business checking account as of July 2022; additionally \$182.34 in the reimbursable expense account with the city of San Diego. Hugh Rothman motioned to approve the Treasurer's report as submitted; seconded by Robin Kaufman; motion was approved 12-0-0.

# San Dieguito River Valley Regional Open Space Park Citizens Advisory Committee June 24, 2022

<u>Call to Order</u> – Chair Chris Khoury. Roll call, minutes from last meeting approved. <u>Chair's report</u> - Attendance - Regarding a quorum, JPA attorney recommends waiting 15 minutes, and then cancelling if no quorum. Recommended not having informational meeting which was proposed. Will abide by this. JPA meeting cancelled for June. Discussion of alternates to cover for those who cannot attend due to scheduling conflicts. All must be approved by JPA before voting.

### **Exec Director's Report**

Sikes Adobe event a success. Good attendance from all, including Congressmen Scott Peters attended.

JPA and partners received at \$258k state parks grant for outdoor equity program. Will fund watershed explorers for 3 years to bring underserved youth in Escondido.

New rangers hired in May. Anthony, Jose, and Dylan. Orientation for new CAC member and representatives to be scheduled to explain CAC and JPA. August or September.

# Public comment. None.

**Discussion** - Shawna - SURF cup trail and property activities

**CAC purpose** is to advise JPA board on land use matters in affected areas. SURF has long term lease. But acquired a new property nearby in May. Leased from City who owns this property. Was set aside when Fairbanks ranch was developed as open space and is supposed to remain this way. Concern that land use by SURF is expanding and no buffer for trail.

**No Buffer**- Previous requests by JPA have been ignored by the city. 100 ft buffer requested and denied. Impact to the habitat when too close to the river. Not sustainable. Have tried to work with SURF.

Maggie- Company wants to build a senior facility. Parcel is a concern. Friends filed against SURF for abuse of wetlands. Code compliance is understaffed and complaint still active.

**Questions:** Where is the mitigation for surf cup destruction of wetlands? 2. How can SURF spend 6.6 million for parking but ignore their obligations to restoration of wetlands? City allows it to continue. Long discussion about how to get surf to comply. May write asking JPA to get involved.

# Status of Coast to Crest Trail Gap Funding Campaign - Shawna

East San Pascual Gap, and Lake Sutherland gaps were discussed. Cindy Outlaw introduced- has background w trail and fundraising. Discussed campaign timeline to raise money. First is a feasibility study. Then kickoff Nov 6, 2022, at River Valley Fest. Confident they can raise between \$1.5-\$2mil for campaign for the JPA. Vote to proceed w campaign passed.

# Amended Trail easement for Ozuna segment of Coast to Coast Trail.

Shawna. Environmental issue came up. Had to work with property owner to get the easement permitted. Recorded amendment to reroute part of the trail. Amendment approved.

Sue Carr approved. Local realtor, has attended meetings in past. Will act as alternate if one of the other two coastal property members cannot be present.
