ITEM #1 Call to Order/Roll Call:

Chair, Robin Kaufman called the meeting to order at 7:00pm.

ITEM #2 Chair remarks:

Chair, Robin Kaufman welcomed everyone to the meeting. She commented that the meeting is being recorded for accuracy in the meeting minutes, and noted that it is being conducted as if it were in in-person and that participants should extend all courtesies as such.

Robin Kaufman noted that a community member has been posting negative and inaccurate comments about the Planning Board on the NextDoor social media platform; this community member has been cordially invited to participate in the recurring monthly Planning Board meetings in the past but has chosen to not attend.

Finally, the chair thanked the Election Committee members and volunteer community member for their hard work over the past few months in facilitating the 2022 RB Planning Board election.

ITEM #3 Non-agenda public comment (3 minutes per speaker):

Mike Stichter provided some follow-up information about the proposal for the AT&T cell tower at the RB Swim & Tennis Club site. This was a previous RB Planning Board agenda item in which the board voted against the proposed cell tower location. Mike Stichter noted that the RB Swim & Tennis Club Board suggested that they would continue to pursue the proposal should the city *not* consider the Planning Board's

position, so he submitted a letter to each board member reminding them of the debate and discussion on this matter across the community.

ITEM #4 Government Staff Reports (Information Item):

Giana Belsito from the office of <u>Supervisor Joel Anderson</u> (San Diego Country District 2) provided a short update on the a Board of Supervisor's meeting. She noted that the Supervisor's office has submitted a letter to Governor Newsome asking for a suspension of the state's \$0.51/gallon gas tax as well as voicing support for the Governor's proposed tax rebate to counter rising fuel costs.

ITEM #5 Modification and Adoption of Agenda (Voting Item):

Motion duly made by Benjamin Wier to adopt the agenda; seconded by Joni Edelman; approved 8-0-0.

ITEM #6 Administrative Items (Voting Item):

Approval of February 2022 Meeting Minutes was motioned by Sonny Googins; seconded by Gary Long; approved 6-0-2 (Joni Edelman and Hugh Rothman abstained due to absence at the February 2022 meeting).

Gary Long presented the Treasurer's Report: the Board has \$322.95 as of February 22. Gary Long motioned to approve the Treasurer's report; seconded by Hugh Rothman; approved 8-0-0.

Robin Kaufman noted that the City intended to give update about in person meeting next month.

ITEM #7 Proposed Retail Cannabis Ordinance Amendments (Information Item):

William Perno, Senior Prevention Specialist with Social Advocates for Youth (SAY) San Diego, was scheduled to give a presentation on the proposed retail cannabis ordinance amendments followed by a Q&A session. Unfortunately, William Perno was not present at the meeting and will be rescheduled for a future board meeting.

Note: Board Member Thomas Lettington joined the meeting at this time.

Community Planners Committee (CPC)

-A presentation on Capital Improvement Projects was presented – it revolved around the process of requesting a CIP and how the City determines priorities for them.

-William Perno from SAY San Diego gave his presentation on regarding Proposition 64 and the ability for local jurisdictions to have regulations that exceed minimal requirements under state law. This was the same presentation he gave at our February meeting.

-City Councilmember Stephen Whitburn was to give a presentation on his proposed amendments to cannabis outlet ordinance 141.0504. He pulled out from giving the presentation 2 days prior to the meeting. His director of policy cited he was pulling the agenda from the CPC meeting until after the City implements a social equity program.

-Action item pertaining to changes in Council Policy 600-24 and 600-9 turned into a discussion on the matter. Wally Wulfeck, Chair of CPC was very frank in his feelings on the matter. He, and others, feel Councilmember Joe LaCava deflected our attention on reducing planning groups input by proposing so many changes. The Councilmember then agreed to most of the concerns addressed, still leaving the charges for review processes, the two year absence before applying again for a planning group, only allowing a termed out member to present oneself when the group is 10 members or less. Wally strongly encouraged all groups to reach out not only to their own City Councilmember, but all members and push for these matters.

-This was Wally Wulfeck's last meeting as chair of the CPC. He is termed out as a member of the Scripps Ranch Community Planning Group.

<u>RB Community Council Summary</u>

The Board discussed and approved the annual Directors and Officers insurance payment;

The Board discussed and approved a letter pertaining to Net Energy Metering to be sent to the Governor's office and CPUC commissioners;

The Board tabled a proposed cannabis retail ordinance letter until the City has updated information on the matter;

The Board discussed and approved up to \$100 for the earth day fair expenditures (April 10, 10 am - 1 pm);

The Board discussed and approved up to \$100 for the RB Alive booth (June 5, 10 am through 3 pm)

The Board approved the date and activities for the 2021 Safety Fair (October 2. 10 am through 2 pm – included chili cook off between police and fire departments as fundraiser);

The Board reviewed the upcoming election process and who is up for elections in 2022;

The Board was given an update on how much new and gently used sports equipment has been donated so far. Items will be given to less fortunate recreation centers in the City;

The Board was given an update on the chalk it up event taking place May 7.8 am through 3 pm

Traffic and Transportation summary

The subcommittee reviewed complaints from residents pertaining to numerous accidents at the intersection of Capilla and Matinal Rd in the Westwood area. It was agreed at this time to reach out to the club manager to encourage the residents on the corner to trim their bushes and to reach out to traffic engineering for a traffic review of the intersection;

The Subcommittee reviewed concerns of constant vehicle crashes along westbound Rancho Bernardo Road between Bernardo Oaks Drive and Acena. Traffic engineering has been contacted to review the area to see what traffic calming measures can be implemented.

<u>Two Presentations - 1) Sandra Carlson- Public Utilities Department -</u>Groundwater Sustainability Plan for San Pascual Valley Groundwater Basin.

 SGMA- 2014– Sustainable Groundwater Management Act is to prevent overdrawing of water. GSA (Groundwater Sustainability Agency –here, San Pascual) had to prepare a GSP Groundwater Sustainability Plan for San Pascual Valley. Basin currently sustainable, but we have to ensure it stays that way. City owns 90% of the basin. 1994 ordinance made San Pascual Valley an agricultural preserve. City leases to farmers and crop growers. No imported water. All irrigation for ag users is groundwater. Future projections look good.

2) Olivenhain Municipal Water Proposed San Dieguito Valley Groundwater Desalination Project -Joey Randall-Assistant Director

• Imported water getting more expensive. Goal to get a portion to come from groundwater basin instead of importing. \$42 million project. Currently only for OMWD customers but water saved there is good for overall usage. Seawater is more costly, and Surfrider Foundations, etc. prefer groundwater to seawater for environmental reasons. Competitive with imported water and cheaper than desalinated sea water. Pump test worked. Well water recovered completely. Minimal to no impact on aquifer. Still testing. Proposal would use about 1% of groundwater basin.
