#### **INFORMATION ITEMS**

# **301.** Mission Trails Flow Regulatory Structure II construction and Vernal Pool Habitat Site Restoration Transfer. – *SDCWA staff*

- The tank installation is nearly complete and backfill of the site has begun.
   June 12-21 connection testing will be conducted, and then the remaining vents will be removed.
- Once the tank is complete and backfilled, temporary irrigation will be installed and plant material will be put in place. The goal is to return the area to its original condition.

- **302.** San Diego River Crossing Bridge project PRJ 1050170 Ben Lenail, Project applicant and Evan Lakin KPFF.
  - Currently in a period of quiet and deliberate work being done to advance the project. Currently \$900,000.00 has been raised through the San Diego Foundation. The first payment has been made to the City toward the project. Currently it is anticipated that construction will start late summer of fall of 2023. KPFF is currently doing most of the heavy work including applying for permits and developing designs.
  - Vice-Chair Dick Murphy requested a CAC field trip to the area where the proposed bridge would cross the San Diego River, to view potential sites on the San Diego River Crossing Trail.

# **303.** Priority trail improvement projects for use of AB129 grant funds – Ryan Robertson

 The City is in the process of soliciting quotes for resurfacing of the Oak Grove loop trail

# **304.** FY 2023 City of San Diego Mayor's budget proposal relating to the Open Space Division of the Parks and Recreation Department – Ryan Robertson

• There are no proposed new positions for Mission Trails but there are several additions to the Parks and Recreation budget overall. Some of which will provide additional support for the park.

# **305.** Old Mission Dam Dredging - Ryan Robertson

 \$750,000.00 is included in the FY 23 proposed budget for completion of the project

### **306. West Sycamore Staging Area Improvement Project (B-17180)** – Ryan Robertson

Project is still in the design phase with no new information to share currently. Erika
Ferreira reported that there is \$500,000 in the proposed Regional Parks Improvement
Fund budget for the project.

## **307. Stowe Trail update** – *Ryan Robertson*

• City staff is meeting next week to visit and discuss the potential mitigation area proposed for the project. The area is within the Park Boundaries and is adjacent to the campground/day use parking lot.
