<u>CITIZENS' ADVISORY COMMITTEE / MTRP FOUNDATION REPORT – Dorothy Leonard</u> **MTRP CAC Report**

At the March 2 meeting of the CAC, the committee asked the City to provide some info at the
next meeting. Information asked for included; a brief report analyzing the feasibility of
constructing a bridge over the San Diego river along the San Diego River Crossing trail, any
physical limitations, possible types of structures, seasonal or year-round crossable, and cost
estimates.

MTRP Foundation Report

- Working with City staff, the Foundation has applied for a grant to fund the Old Mission Dam dredging project. A grant to fund the project is needed due to a lack of City funds.
- The online lecture series continues to be very popular. The next Geology lecture has 660 participants signed up.

301. San Diego River Crossing Bridge - Michelle Abella-Shon, City of San Diego Project Officer II

 A Power Point presenting several of the on-going park priorities, some elements from the Master Plan, and a brief breakdown of the differences between public vs. privately funded projects on City property. A brief description of the known and potential permits and monitoring that would be mandated for projects regardless of funding source was also provided.

Public comments related to the information item:

- Ben Lenail and Laurie Yoler informed those present that their son Max had recently died while trying to cross the San Diego river. As a result of this tragedy, they are working with the City in an effort to have a bridge constructed over the river in the area where their son died. As a part of this effort, they have retained a Design and Engineering firm that will be presenting their findings today. They have three asks today of the Task Force. One is that the City join in their private fundraising efforts and work with them to raise funds for the project. Two is that the City pick one of the three bridge options that will be presented later, and three that the City initiate the project by starting to develop the project scope.
- Steve Merritt, KPFF Consulting Engineers, presented three possible bridge options that his company had developed and cost estimates for the three.
- Cynthia Wootton, Sierra Fang-Horvath, Kai Johnson, Susie Murphy, Susie Brusa, Sonia Arrison Senkut, and Patricia Murphy all spoke in support of constructing a bridge over the San Diego River.

• Peggy Johnson, Amy Wo, Rohan Gandi, Nicki Ellis, Scott Turner, and Robert Kay all submitted written statements in support of building a bridge over the San Diego River. All submitted written statements were read aloud at this time.
