

CONSTRUCTION NOTICE:

Construction Scheduled to Begin in La Jolla Village Drive and Towne Centre Drive Intersection from June 18 to July 2

June 9, 2023

Beginning June 18, 2023, construction will start in the Towne Centre Drive and La Jolla Village Drive intersection as part of the City of San Diego Morena Northern Pipelines and Tunnels project in University City.

For public and construction crew safety, and for construction efficiency, the intersection construction will include two phases and lanes will be shifted around the construction zone in each phase to maintain two-way traffic on La Jolla Village Drive at all times. Construction will occur 24 hours a day.

Construction will be phased over approximately two weeks, starting with the north side of the intersection, followed by the south side of the intersection. From approximately Sunday, June 18 to Saturday, June 24, the northern portion of the Towne Centre Drive and La Jolla Village Drive intersection will be closed, followed by the closure of the southern portion of the intersection, from approximately Sunday, June 25 to Sunday, July 2. Construction teams will be installing one 48-inch wastewater pipeline and one 30-inch brine pipeline in a 20-foot-deep trench through the intersection. For access to businesses on southbound Towne Centre Drive, north of La Jolla Village Drive, please use Executive Drive. For access to businesses on southbound Towne Centre Drive, south of La Jolla Village Drive, please use Nobel Drive.

Please plan extra time when traveling on La Jolla Village Drive or Towne Centre Drive or avoid the intersection. If possible, please use Interstate 5 to access University City instead of Interstate 805. The City and project team are committed to completing construction through the intersection as efficiently as possible, and the community's patience and coordination are appreciated.

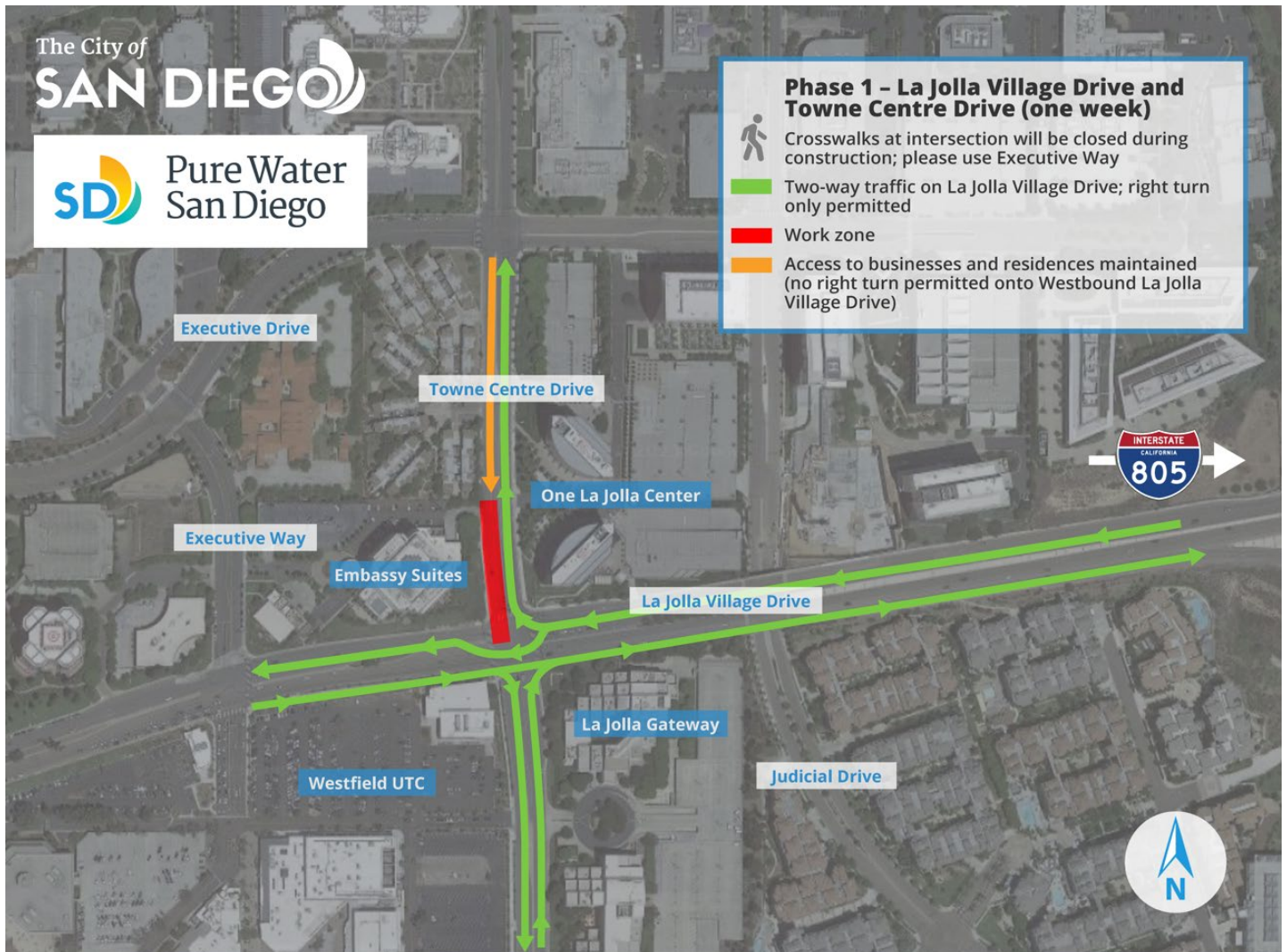
All lanes on La Jolla Village Drive will re-open when both phases are complete. Final street and median restoration on La Jolla Village Drive is anticipated to be completed in Fall 2023.

What to Expect:

- Construction in the intersection will begin June 18, 2023, and is scheduled 24 hours a day for approximately two weeks. As with all underground construction, the schedule is subject to change.
- For the safety of the public and construction crews, a concrete barrier will be installed on La Jolla Village Drive to separate traffic from the construction zone.
- Two-way traffic on La Jolla Village Drive will remain open.
- In the work zone, there are no turns permitted except on northbound Towne Centre Drive from eastbound La Jolla Village Drive. For access to businesses on Towne Centre Drive north of La Jolla Village Drive, please use Executive Drive. For access to businesses on Towne Centre Drive south of La Jolla Village Drive, please use Nobel Drive.
- Crosswalks will be closed during construction; pedestrians should cross at Executive Way.
- 24/7 access for emergency vehicles, residences and businesses will be maintained.

- 24/7 access to the Interstate 805 ramps will be maintained.
- For safety reasons, please follow all posted signage including detours for traffic on Towne Centre Drive. Please anticipate traffic delays, construction noise and overnight construction lights.
