COMMUNICATIONS:

- 1. City Council District 5 – Councilmember Marni von Wilpert (Quinton Grounds provided a written report that was read):** “The new Fiscal Year has begun and the new budget included significant infrastructure repair funding that we’re currently advocating to see used in District 5. We’ve also worked with our fellow Council offices to dedicate \$200K to SDPD specifically for dragnet operations to combat illegal racing, sideshows, and exhaust. While a little farther south, we also saw the ADA improvements for Jerabek Park fully funded and are looking forward to seeing it into the next phase.”
- 2. City Mayor Todd Gloria (Emily Piatanesi provided a written report that was read):**

Homelessness

- The Safe Parking Program was approved by City Council on Monday June 27th, 2022. This will expand hours at the Mission Valley site to 24 hours. This will allow more individuals to access a safe parking space and a connection to service providers.
- Zero bail is no longer in effect, meaning we can more effectively enforce the city codes including, encroachment and illegal lodging.
- The City of San Diego’s Homelessness Strategies and Solutions Department recently launched a new website. Infrastructure

On June 17th, the FY23 “Ready to Rebuild” budget was signed. This became effective on July 1st, 2022.

- Totaling, \$5.06 billion dollars this budget has the the largest infrastructure investment in City history ~\$77 million dollars.

“Employ & Empower” Youth Workforce Program

The City of San Diego received an \$18.5 million grant via the State of California through the Californians For All Youth Job Corps. This program will provide 1,000 opportunities for youth ages 16-30 to gain real-world, paid work experience to help serve their community. Most specifically the intended youth include..

- Those have difficulty finding employment
- Low-income
- Unemployed and/or out of school
- Involvement with the justice system
- Transitioning from foster care
- Engaged with substance use or mental health systems
