Subject: Construction to Begin on the North City Pure Water Pipeline and AC Water Group 1038 in Your Area

Dear Property Owner or Tenant,

In June 2021, the City of San Diego will begin construction on the North City Pure Water Pipeline – one of several major water infrastructure projects that are part of Pure Water San Diego. This multi-year program will provide nearly half of San Diego's water supply locally by 2035 through purifying recycled water to produce safe, high-quality drinking water.

The North City Pure Water Pipeline and AC Water Group 1038 will be constructed in the Scripps Ranch and Miramar communities. The eight-mile long North City Pure Water Pipeline and six-mile-long AC Water Group 1038 will be constructed on Eastgate Mall, Miramar Road, Kearny Villa Road, Candida Street, Via Pasar, Via Excelencia, and a tunnel under Interstate 15. In Scripps Ranch, the alignments include Businesspark Avenue, Carroll Canyon Road, Hoyt Park Drive, and Meanley Drive, as well as a tunnel under Scripps Lake Drive to the Miramar Reservoir.

The Pure Water Pipeline also includes a dechlorination facility, which will remove chlorine that had previously been added for disinfection and pipe protection before the purified water is stored in the Miramar Reservoir, and a one-mile-long subaqueous pipeline that will be sunk and permanently installed on the floor of Miramar Reservoir to ensure even distribution of the purified water throughout the reservoir.

Anticipated Construction Schedule

Construction is expected to take place between June 2021 and early 2025. For more detailed schedule information, please visit **phase1.purewatersd.org**.

What to Expect During Construction

- Access maintained for residents, businesses, Marine Corps Air Station Miramar, and emergency responders
- One lane open in both directions at all times, but street parking will be temporarily removed near pipeline construction
- Construction-related noise and heavy equipment
- Scheduled water outages for the construction of AC Water Group 1038
- Nighttime construction from 9 p.m. to 5 a.m. from Sunday to Thursday along the pipeline alignment
- 24/7 construction at tunnel crossing at Interstate 15
- Temporary interruption to pedestrian access in the Evans Pond area

What to Expect During Construction (Continued)

- Daytime construction scheduled from 7 a.m. to 4:30 p.m. from Monday to Friday at Miramar Reservoir
- Boating closed at Miramar Reservoir; shore fishing, parks, and trail will remain open
- Posted detours for sidewalks, bike lanes, and trails
- Additional temporary parking at Miramar Reservoir
- Temporary relocation of the boat dock at Miramar Reservoir

The City is committed to keeping residents and businesses proactively informed throughout construction and to resolving issues that may arise during construction. The construction outreach team will deliver a doorhanger to neighboring properties up to five business days before the start of construction and a minimum of three business days prior to any scheduled water outages. Regular schedule information will be distributed via email and posted on the project webpage. The City will coordinate with LOSSAN Rail Corridor Agency for any scheduled railroad crossing impacts at Camino Santa Fe and Miramar Road and will be in regular contact with MCAS Miramar for any military base impacts.
