Councilmember Gloria Calls on San Diegans to Weigh in on City Budget

Councilmember Gloria to Chair Budget Review Hearings Beginning May 4

SAN DIEGO, CA (April 18, 2016) – Councilmember Todd Gloria today released the budget review calendar and encouraged San Diegans to provide input on the Fiscal Year 2017 budget proposed by Mayor Kevin L. Faulconer. The full budget proposal is available online: http://www.sandiego.gov/fm/proposed/index.shtml.

"In my sixth and final year as chair of the City's Budget and Government Efficiency Committee, I am committed to ensuring the City's budget is focused on critical issues for San Diegans like infrastructure, neighborhood services, addressing homelessness, and funding implementation of our Climate Action Plan," said Councilmember Gloria. "I look forward to leading the City Council in reviewing the Mayor's proposed budget in greater detail during the month of May and urge the public to weigh in with their priorities."

The Mayor's proposed budget will be presented to the City Council at 2 p.m. tomorrow, April 19. During the first two weeks of May, the City Council, sitting as the Budget Review Committee, will consider each department's budget separately and take public comment before the Mayor releases his May Budget Revision.

The full budget review calendar is attached. In addition to the hearings listed, the City Council will review the FY 2017 May Revise and FY 2016 Year-End Budget Monitoring Report on Thursday, May 19, 2016 at 2:00 p.m.
