# COVID-19 Updates

## County

### [In-person Dining is an Open and Shut Case](#)

As of today, an appeals court has blocked a judge's decision to halt enforcement of COVID-19 restrictions against San Diego County restaurants and live entertainment. This means that on-site operations are not allowed and Governor Newsom's stay-at-home order is in full effect. That being said, we can (and should) continue to support our local businesses even if we are unable to engage with them in-person. I encourage you to shop, dine, and gift locally, even if that looks like takeout or a gift card at the moment. We are living in fast times and, as always, my office is here as a resource for you. ### [San Diego County Receives Its First Shipment of Moderna COVID-19 Vaccine](#)

On December 21, San Diego County received 20,000 doses of the Moderna vaccine, the second COVID-19 vaccine approved by the Food and Drug Administration.

This shipment is the first to deliver a portion of the allocated 43,700 doses to the region. These 43,700 doses of Moderna's vaccine are in addition to the roughly 28,000 doses of Pfizer vaccine that started arriving in San Diego County last week.

## State

### [Small Small-Businesses May Apply for 90-Day Tax Extension](#)

Governor Newsom issued an executive order providing a 90-day extension on tax returns and tax payments for small businesses.

Now, small businesses filing a return for less than \$1 million in taxes will be able to apply for a tax extension, giving them until the end of July to file first-quarter returns.

## Federal

### [\\$900 Billion Federal Stimulus Package On the Table!](#)

On Monday, December 21, Congress passed a bipartisan COVID-19 stimulus package. While there are many elements in this massive 5,600-page bill, some key benefits are:

- \$600 direct checks to individuals
- \$300 supplemental federal unemployment benefits for 11 weeks
- Funding for State and Local Rental Assistance (California estimated to receive over \$2.6 billion)
- \$284 billion for businesses (and the revival of the [Paycheck Protection Program](#))
- Extending the eviction moratorium through January 31, 2021
- Funding for COVID testing, tracing, and vaccinations
- Money for schools, childcare and food assistance

What the package did not include is direct aid to states and cities like the CARES Act provided, which means no budgetary relief to our city's financial shortfall. Despite this, I am committed to preserving core neighborhood services and working with the Mayor and my fellow councilmembers to balance our budget.

The next step for this deal is presidential approval.

## News from City Hall

### A Word on the Council President Vote and Committee Assignments

At my inauguration, I stated that I am ready to work with my City Council colleagues to ensure that every San Diegan in every neighborhood has the opportunity to enjoy what our great city has to offer. As such, I am pleased that Councilmembers Sean Elo-Rivera, Monica Montgomery-Steppe, and Vivian Moreno will chair significant council committees. They have pledged to tackle inequities within San Diego and act on behalf of our historically under-resourced communities and will drive needed conversations into the open, spur progress, and change our city for the better.

As vice chair of the Audit Committee and Active Transportation and Infrastructure Committee, I too pledge to do my part to advance an agenda of solutions, transparency, and equity.

I am optimistic about the leadership that all my colleagues will bring to their respective committees. I look forward to working with Council President Campbell and all my council colleagues.

### An Update on the Invitation to (Not) Bid for the Franchise Fee

After an extensive Invitation to Bid period to become San Diego's new electric and gas provider, it was revealed on December 18 that [Mayor Gloria rendered SDG&E's bid \(the only bid received\) unresponsive, thus rejecting the offer](#). The City is currently pursuing extending the existing agreement between the City and SDG&E to allow enough time for more opportunities for public engagement to occur.
