NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PLANNING DEPARTMENT

PROJECT NAME/NUMBER: Right of Entry Permit for SDG&E

COMMUNITY PLAN AREA: Midway District

COUNCIL DISTRICT: 2

LOCATION: 4077 North Harbor Drive, San Diego, CA 92101

PROJECT DESCRIPTION: Authorize the Mayor or his designee to sign a Right of Entry Permit between the City of San Diego, a California municipal corporation and San Diego Gas and Electric (SDG&E), a California corporation to operate a communication facility on a non-exclusive basis on an approximately 8 square foot area located on the southwest corner of the rooftop of the City Property, also known as Sewage Pump Station #2. This SDG&E operated facility is an outdoor, roof top antenna mounted on the side of the lower roof top parapet, with the approximate dimensions: H 14.8' x W 14.8' x D 3.6" and a weight of 7 lbs.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically Exempt from CEQA pursuant to CEQA Guidelines Section 15301 (Existing Facilities).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor–Appointed Designee.

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:

The City of San Diego conducted an environmental review and determined the project is exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities), which allows the operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of existing or former use. The exceptions to the exemptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
