NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PROJECT NAME/NUMBER: Las Chollas Creek Streambed Restoration – Sunshine Berardini Restoration Project (WBS# S-24005)

COMMUNITY PLAN AREA: Mid-City: City Heights and Mid-City: Eastern Area **COUNCIL DISTRICT:** 4 **LOCATION:** Chollas Creek from Sunshine Berardini Park to Euclid Avenue

PROJECT DESCRIPTION: This action is for the approval of a task order with HDR, Inc. to provide professional engineering, surveying, and landscape architectural design services for the Las Chollas Creek Streambed Restoration - Sunshine Berardini Restoration project (project). This task order will authorize HDR, Inc. to complete the preparation of the plans, specifications, and cost estimate (PS&E) for the project. The scope of work for the task order includes project management; planning and design of the project; preparation of technical reports, investigations, and studies; data collection and review; permitting; environmental analysis of the project; consultation work; public outreach; and bid phase services. Limited potholing, shovel test pits, and geotechnical and groundwater investigations are proposed to support engineering design, planning, and permitting work. All work will be conducted in accordance with the City's Land Development Code, Land Development Manual, and other standards and guidelines including, but not limited to, the Standard Specifications for Public Works Construction (i.e., The "GREENBOOK") 2021 Edition, the City's Standard Specifications for Public Works Construction (i.e., "The WHITEBOOK") 2021 Edition, and any applicable technical or informational bulletins published by the City's Development Services Department.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: This activity is statutorily exempt from CEQA pursuant to CEQA Guidelines Section 15262 (Feasibility and Planning Studies).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee.

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:

The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to CEQA Guidelines Section 15262 (Feasibility and Planning Studies) which exempts a project involving only feasibility or planning studies for possible future actions which the agency, board, or commission has not approved, adopted, or funded does not require the preparation of an EIR or Negative Declaration, but does require consideration of environmental factors. The proposed task order will simply facilitate the planning and design of the Las Chollas Creek Streambed Restoration – Sunshine Berardini Restoration project. The Las Chollas Creek Streambed Restoration – Sunshine Berardini Restoration project will be subject to environmental review at a future date in accordance with the City's Land Development Code and CEQA Guidelines Section 15004, which provides direction to lead agencies on the appropriate timing for environmental review.

You must separately mail the appeal fee by check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. The appeal filing fee must be United States Postal Service (USPS) postmarked before or on the final date of the appeal.


