## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

**PROJECT DESCRIPTION:** Authorize the Mayor or his designee to sign a Right of Entry Permit allowing Permittee (Diamond Designs LLC, a Limited liability company, to provide laser leveling services on lighted infield. Scope to include: Laser level existing skin. Use Kubota Tractor with discs to open up infield skin and properly level field.

## STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:

The City of San Diego conducted an environmental review and determined the project is exempt from CEQA pursuant to State CEQA Guidelines Section 15302, (Replacement and Reconstruction) which allows for the replacement and reconstruction of existing structures and facilities where the new structure or facility will be located in the same site as the structure replaced and will have substantially the same purpose and capacity as the structure replaced; and where the exceptions listed in CEQA Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway at any location; no historical resources would be affected by the action; and after review of the Envirostar and GeoTracker websites the project was not identified on a list of hazardous wastes sites pursuant to Section 65962.5 of the Government Code.
