## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

**PROJECT NAME/NUMBER:** Sewer and AC Water Group 793A

**COMMUNITY PLAN AREA:** Southeastern San Diego

**COUNCIL DISTRICT:** 8

**LOCATION:** The project is located on various streets including 19th Street, 20th Street, 21st Street, 22nd Street, 24th Street, 25th Street, Commercial Street, G Street, Market Street, Island Avenue, K Street, L Street, and various alleyways.

**PROJECT DESCRIPTION:** Award an as-needed design engineering services contract, for the Sewer and AC Water Group 793A project. Proposed services include, project management and coordination, preparation of design plans, traffic control, potholing for utilities, and geotechnical investigation. Geotechnical investigation would include research, subsurface exploration, and testing to provide recommendation for the project design. Potholing for utilities would also include research and subsurface testing to provide recommendation for the project design.
