NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PROJECT NAME/NUMBER: Electrical and Plumbing laundry room upgrade for Senior Landing

Homeless Shelter

COMMUNITY PLAN AREA: Downtown **COUNCIL DISTRICT:** District 3

LOCATION: 1655 Pacific Highway, San Diego, Ca 92101

PROJECT DESCRIPTION: Upgrade of Electrical & Plumbing systems in the laundry room of Senior Landing Homeless Shelter to provide washer/dryer units. Upgrades are as follows:

- 2" ABS drain lines on 1st and 2nd floor
- 34" and 1/2" copper water lines
- Install new P-traps and shutoffs
- Install (2) new dryer vent lines to rear of building
- Install (2) new exhaust fans
- Install (2) 120/240 volt 30 amp laundry outlets on 1st and 2nd floor

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301(a) (Existing Facilities).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee.

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:

The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section 15301(a), which consists of the operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of existing or former use; including Interior or exterior alterations involving such things as interior partitions, plumbing, and electrical conveyances; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal.

Bring the fully completed appeal application <u>DS-3031</u> (including grounds for appeal and supporting documentation) to the City Administration Building— Public Information Counter (Open 8:00am to 5:00pm Monday through Friday excluding City approved holidays), 1st Floor Lobby, located at 202 C Street, San Diego, CA 92101, by 5:00pm on the last day of the appeal period. The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer.
