NOTICE OF RIGHT TO APPEAL

ENVIRONMENTAL DETERMINATION

PROJECT NAME/NUMBER: AIK00001 New Walkways, College Avenue- Meridian Avenue to Judy McCarty Way Sidewalk, New CIP

COMMUNITY PLAN AREA: Eastern Area

COUNCIL DISTRICT: 4

LOCATION: East side of College Ave between Judy McCarty Way and College Grove Dr, west side of Meridian Ave between Zena Dr and College Ave, San Diego, CA, 92115

PROJECT DESCRIPTION: The proposed project will install new sidewalks on the east side of College Avenue between Judy McCarty Way and College Grove Drive, west side of Meridian Avenue between Zena Drive and College Avenue. All work would occur within the public right-of-way in previously disturbed and non-sensitive areas only. Storm Water Best Management Practices (BMPs) for erosion control preventing discharge, as well as a Traffic Control Plan (TCP) would be implemented throughout construction.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301(c) (Existing Facilities).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee.

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section 15301(c) (Existing Facilities) which consists of the operation, repair, maintenance, permitting, leasing, licensing, or minor alterations of existing public or private structures, facilities, mechanical equipment, or topographical features involving negligible or no expansion of existing or former use including existing highways and streets, sidewalks, gutters, bicycle and pedestrian trails, and similar facilities. The exceptions to the exemptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; and no historical resources would be affected by the action. There are no locations listed on GeoTracker and/or Envirostor within 1,000 feet of the public right-of-way. There are no open environmental cases

of known hazardous material contamination that would be disturbed which would otherwise preclude use of a CEQA exemption pursuant to Section 65962.5 of the Government Code.

During the Statewide "Safer-at-Home" directive to reduce the spread of COVID-19, beginning March 19, 2020, appeals to the City Clerk must be filed by email or US Mail as follows:

Appeals filed by US Mail must have a United States Postal Service (USPS) postmark by the appeal deadline to be considered valid. The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
