## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

**PROJECT NAME/NUMBER:** Consent to Sublicense between Sportsmen's Seafood Company, Inc., and Gone Whale Watching, Inc..

**COMMUNITY PLAN AREA:** Mission Bay Park

**PROJECT DESCRIPTION:** Sportsmen's Seafood Company Inc. wishes to sublease a portion of the leased Master Premises known as "the dock" located at Sportsmen's Seafood, and within City-owned property, to Gone Whale Watching, Inc., a California Corporation, for the operation of a whale watching business consisting of three (3) boats. Under Section IV.2 of the Percentage Lease for the premises, the sublease is not effective unless and until the City consents to the sublease. Therefore, Sportsmen's Seafood Company, Inc. is requesting a City Consent to Sublease.

**ENTITY CONSIDERING PROJECT APPROVAL:** City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities).

**ENTITY MAKING ENVIRONMENTAL DETERMINATION:** City of San Diego Mayor-Appointed Designee.

## STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:

The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to CEQA Guidelines Section 15301 (Existing Facilities), which consists of the operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of existing or former use. The exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified, no significant effects on the environment were identified, the project is not adjacent to a scenic highway, no historical resources would be affected by the action, and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
