PROJECT NAME/NUMBER: Famosa Slough Alley Slope Restoration project

PROJECT DESCRIPTION: This mayoral action will execute a consultant agreement with HDR Inc. to provide professional engineering services for the Famosa Slough Alley Slope Restoration project (Project). This agreement will authorize HDR to complete the preparation of the plans, specifications, and cost estimate (PS&E) for the project.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: This activity is statutorily exempt from CEQA pursuant to State CEQA Guidelines Section 15262 (Feasibility and Planning Studies).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee.

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review and determined the project is exempt from CEQA pursuant to State CEQA Guidelines Section 15262 (Feasibility and Planning Studies) which exempts a project involving only feasibility or planning studies for possible future actions which the agency, board or commission has not approved, adopted or funded and does not require preparation of an EIR or Negative Declaration but does require consideration of environmental factors.
