**PROJECT NAME:** Right of Entry Permit to Install and Maintain Wi-Fi Equipment at Various Recreation Facilities and Pools

**COMMUNITY PLAN AREA:** Balboa Park, Carmel Mountain Ranch, Carmel Valley, City Heights, Clairemont Mesa, Eastern Area, Linda Vista, Mira Mesa, Miramar Ranch North, Mission Bay Park, Navajo, Ocean Beach, Otay Mesa-Nestor, Pacific Highlands Ranch, Peninsula, Rancho Bernardo, Rancho Peñasquitos, San Ysidro, Skyline-Paradise Hills, Tierrasanta, and University

**COUNCIL DISTRICT:** Citywide

**PROJECT DESCRIPTION:** Right of Entry Permit between the City of San Diego, Lokket, Inc. and the San Diego Parks Foundation (Permittees), to allow permittees to access various recreational facilities and pools to install and maintain all equipment required to provide free and public Wi-Fi service.

**ENTITY CONSIDERING PROJECT APPROVAL:** City of San Diego

**ENVIRONMENTAL DETERMINATION:** This activity is categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities) and Section 15304 (Minor Alterations to Land).

**ENTITY MAKING ENVIRONMENTAL DETERMINATION:** City of San Diego Mayor-Appointed Designee.

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section 15301 (Existing Facilities) which consists of the operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of existing or former use; Section 15304 (Minor Alterations to Land) which consists of minor public or private alterations in the condition of land, water, and/or vegetation which do not involve removal of healthy, mature, scenic trees except for forestry or agricultural purposes; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

Applications to appeal CEQA determination to the City Council must be filed with the Office of the Clerk within 10 business days from the date of the posting of this Notice (**May 14, 2021**). During the Statewide "Safer-at-Home" directive to reduce the spread of COVID-19, beginning March 19, 2020, appeals to the City Clerk must be filed by email or US Mail as follows:

The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.

Appeals filed by US Mail must have a United States Postal Service (USPS) postmark by the appeal deadline to be considered valid. You must separately mail the required appeal fee by check payable to the City Treasurer to: **City of San Diego Planning Department, Attn: Tara Ash-Reynolds, MS 413, 9485 Aero Drive, San Diego, CA 92123**. The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
