## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

**PROJECT NAME/NUMBER:** License Agreement for Crane Swing Use

LOCATION: 1222 First Ave., San Diego, CA 92101

**PROJECT DESCRIPTION:** License to operate crane in the airspace above 1222 First Ave (License Area) for the period commencing on the effective date of this license and expiring upon the earliest to occur of completion of the construction of the Project or the permanent dismantling and removal of the Crane by LICENSEE. No loads shall be transported through the License Area.

**ENTITY CONSIDERING PROJECT APPROVAL:** City of San Diego

**ENVIRONMENTAL DETERMINATION:** This activity is categorically exempt from CEQA pursuant to CEQA Guidelines Section 15301 (Existing Facilities).

**ENTITY MAKING ENVIRONMENTAL DETERMINATION:** City of San Diego Mayor-Appointed Designee.

## STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:

The City of San Diego conducted an environmental review that determined the project would not have the potential to cause a significant effect on the environment pursuant to State CEQA Guidelines Section 15301 (Existing Facilities), which consists of the operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of existing or former use. The exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
