## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

## PLANNING DEPARTMENT

PROJECT NAME/NUMBER: Safe Sleeping at "O" Lot in Balboa Park

COMMUNITY PLAN AREA: Balboa Park COUNCIL DISTRICT: 3 LOCATION: Parking lot located adjacent to Nursery Rd; San Diego, CA 92134

**PROJECT DESCRIPTION:** The site will provide tents within a fenced area to provide safe, secure outdoor sleeping accommodations that can serve up to 400 persons experiencing homelessness in the City. The site will operate 24 hours a day, 7 days a week. On-site services will provide access to sanitation resources (i.e. handwashing stations and portable restrooms) and connection to supportive services to prepare individuals experiencing homelessness for the most appropriate longer-term or permanent housing intervention.

## ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities).

**ENTITY MAKING ENVIRONMENTAL DETERMINATION:** City of San Diego Mayor-Appointed Designee.

## STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:

The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section 15301 (Existing Facilities), which consists of the operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of existing or former use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal.
