NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PLANNING DEPARTMENT

PROJECT NAME/NUMBER: Right to Enter Marcy Neighborhood Park to Repair Fence

COMMUNITY PLAN AREA: University

COUNCIL DISTRICT: District 1

LOCATION: Marcy Neighborhood Park at 5504 Stresemann Street, San Diego, CA 92122

PROJECT DESCRIPTION: Authorize the Mayor or his designee to sign a Right of Entry Permit allowing San Diego Unified School District (Permittee), to provide fence repairs and tree trimming along the fence. To remove the old existing fence, some trees will have to be trimmed and one tree will have to be removed which has been evaluated and approved by the City of San Diego's Parks and Recreation Department Arborist. Some of the Permit Area will be used as a staging area for construction materials.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Sections 15301 (Existing Facilities), 15303(e) (New Construction or Conversion of Small Structures), and 15304 (Minor Alterations to Land).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee.

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:

The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section 15301 (Existing Facilities), which allows the operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of existing or former use; Section 15303 (e) (New Construction or Conversion of Small Structures) which consists of the construction and location of limited numbers of new, small facilities or structures including accessory (appurtenant) structures including garages, carports, patios, swimming pools, and fences; Section 15304 (Minor Alterations to Land) which consists of minor public or private alterations in the condition of land, water, and/or vegetation which do not involve removal of healthy, mature, scenic trees except for forestry or agricultural purposes; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were

identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
