# **NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION**

**PROJECT NAME:** Special Use Permit for the Rancho Bernardo Community Tennis Club at Rancho Bernardo Community Park

**COMMUNITY PLAN AREA:** Rancho Bernardo

**COUNCIL DISTRICT:** District 5

**LOCATION:** Rancho Bernardo Community Park and Recreation Center, 18488 West Bernardo Drive, San Diego, CA 92129

**PROJECT DESCRIPTION:** Special Use Permit (SUP) between the City of San Diego (City) and the Rancho Bernardo Community Tennis Club (Permittee) for the non-exclusive use of city-owned property, commonly known as Rancho Bernardo Community Park and Recreation Center at 18488 West Bernardo Drive, San Diego, CA 92129 (Premises). The Premises will be used only for the purposes of tennis club and tennis court related activities such as maintenance of the tennis courts which includes activities like tennis court resurfacing, replacing and repairing tennis court accessories, tennis court lighting, and cleaning the walkways and non-court areas on the Premises in compliance with the current level of Emergency Water Regulations with respect to water usage and all applicable water restrictions relating to water quality assurance and storm water management.

**ENTITY CONSIDERING PROJECT APPROVAL:** City of San Diego

**ENVIRONMENTAL DETERMINATION:** This activity is categorically exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15301 (Existing Facilities).

**ENTITY MAKING ENVIRONMENTAL DETERMINATION:** City of San Diego Mayor-Appointed Designee.

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:**

The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to CEQA Guidelines Section 15301 (Existing Facilities) which consists of the operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of existing or former use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified, no significant effects on the environment were identified, the project is not adjacent to a scenic highway, no historical resources would be affected by the action, and the project was not

identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
2. Appeals filed In-Person: The appeal application can be obtained in the Lobby of the City Administration Building located at 202 'C' Street, San Diego, CA 92101. The completed appeal package must include the required appeal fee in the form of a check payable to the City Treasurer to: **City of San Diego Planning Department, Attn: Tara Ash-Reynolds, 9485 Aero Drive, MS 413, San Diego, CA 92123**.
