NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PROJECT DESCRIPTION: The proposed task order will provide for surface monitoring, data management and reporting on a quarterly basis to ensure compliance with Assembly Bill 32, Landfill Methane Rule, requirements. Monitoring and data collection will take place above the landfill surface and will not overlap with the Multi-Habitat Planning Area or any Environmentally Sensitive Areas.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: This activity is categorically exempt from CEQA pursuant to State CEQA Guidelines Sections 15262 (Feasibility and Planning Studies) and 15306 (Information Collection).

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:

The City of San Diego conducted an environmental review and determined the project is exempt from CEQA pursuant to State CEQA Guidelines Section 15262 (Feasibility and Planning Studies), which exempts a project involving only feasibility or planning studies for possible future actions which the agency, board or commission has not approved, adopted or funded and does not require preparation of an EIR or Negative Declaration but does require consideration of environmental factors; and Section 15306 (Information Collection), which allows basic data collection, research, experimental management, and resource evaluation activities which do not result in a serious or major disturbance to an environmental resource. These may be strictly for information gathering purposes, or as part of a study leading to an action which a public agency has not yet approved, adopted, or funded.
