


## CONSTRUCTION NOTICE: Road Resurfacing and Striping Scheduled for July 20-21, 2023 for North City Pure Water Facility & Pump Station Project

July 20, 2023

Asphalt maintenance and restoration roadway resurfacing is anticipated on Eastgate Mall between Eastgate Drive to Judicial Drive associated with the North City Pure Water Facility, part of the Pure Water San Diego Program. The asphalt construction paving activity work will occur during the day from 8 a.m. to 5 p.m. from July 20-21, 2023.

Flaggers will be on-site to direct eastbound and westbound traffic during this work, which involves grinding, sawcutting, and restoration paving. Access along Eastgate Mall will be maintained, but the road will be periodically temporarily reduced to one lane of traffic. Full unimpeded travel in each direction will reopen upon completion of this work on July 21, 2023.



## **About the North City Pure Water Facility**

The North City Pure Water Facility is the cornerstone of several major water infrastructure projects that are part of Pure Water San Diego. This multi-year program will provide nearly half of San Diego's water supply locally by 2035 through purifying recycled water to produce safe, high-quality drinking water.

The North City Pure Water Facility and Pump Station will clean the recycled water produced at the North City Water Reclamation Plant using a proven five-step purification process to provide 30 million gallons per day (mgd) of highly purified water. The pump station will then convey the 30 mgd of purified water to Miramar Reservoir, where it will be stored before receiving additional treatment at the Miramar Water Treatment Plant. The new facility will be constructed on the north side of Eastgate Mall between Eastgate Drive and Interstate 805 and will include a visitor/discovery center.
