## Construction Notice: Night Work to Start April 18 in Your Area for North City Pure Water Facility

Construction is ongoing for the City of San Diego North City Pure Water Facility and Pump Station, the cornerstone of several major water infrastructure projects that are part of Pure Water San Diego. This multi-year program will provide nearly half of San Diego's water supply locally by 2035 through purifying recycled water to produce safe, high-quality drinking water.

Beginning April 18, through approximately July 2022, nighttime construction will occur on Eastgate Mall between Eastgate Drive to Judicial Drive from 9 p.m. to 5:30 a.m. from Sunday nights to Thursday nights. Crews will be constructing a pipeline across Eastgate Mall between the North City Pure Water Facility project site and the North City Water Reclamation Plant. The pipeline will convey the recycled water at the North City Water Reclamation Plant to the North City Pure Water Facility for advanced purification.

This work will involve excavation, shoring, pipeline installation and road restoration. Eastgate Mall between Judicial Drive and Eastgate Drive will be fully closed during overnight work hours. Vehicles will be routed to La Jolla Village Drive/Miramar Road by traffic control, and detour signs will be posted. Water and utility service interruptions are not anticipated, but nearby properties will be notified by the contractor if service outages occur.



## What to Expect

- Nighttime construction between April 18 to July 1, 2022; Sunday nights to Thursday nights from 9 p.m. to 5:30 a.m.; dates are subject to change as construction progresses
- Full road closure on Eastgate Mall from Judicial Drive to Eastgate Drive with posted detour on La Jolla Village Drive
- Traffic control will be in place for safety of public and construction crews
- Construction-related noise and heavy equipment
- Access to Eastgate Mall will be maintained during the day with plated trench crossings.

## About the North City Pure Water Facility

The North City Pure Water Facility and Pump Station will clean the recycled water produced at the North City Water Reclamation Plant using a proven five-step purification process to provide 30 million gallons per day (mgd) of highly purified water. The pump station will then convey the 30 mgd of purified water to Miramar Reservoir, where it will be stored before receiving additional treatment at the Miramar Water Treatment Plant. The new facility will be constructed on the north side of Eastgate Mall between Eastgate Drive and Interstate 805 and will include a visitor/discovery center.

Construction is expected to take place between 2021 and mid-2025, with the majority of work anticipated to be completed by mid-2024. For more detailed schedule information and maps, please visit **phase1.purewatersd.org**.
