Welcome and Introductions

Introductions of members, review meeting agenda

Brief Review of Working Group Meeting - October

The working group added organizations to both activities. The additions were groups who are already doing work in the San Diego Promise Zone. Activities were altered so that partners may be included in the effort to increase collaboration. The modifications included disseminating information through different partners and building relationships with businesses to implement CPTED (Crime Prevention Through Environmental Design). The corresponding changes were made to outputs and outcomes in the logic model.

Increasing Access to Healthcare and Healthy Foods: Subgoal D

The Creating a Priority of Safety Working Group looked at the Increasing Access to Healthcare and Healthy Foods Working Group Subgoal D to identify where there could be an opportunity to work collectively on improving infrastructure.

- Subgoal D: Increase community support and opportunities for active living
- Activity 2: Climate Action Plan and Vision Zero (zero pedestrian deaths) infrastructure and community engagement and education.

Review of the Creating a Priority of Safety Logic Model

As the group reviewed the completed work on the logic model so far, they explored the necessity to engage more partners, specifically talking about community input and engagement strategies. They all agreed that collectively they wanted to do more research to come up with a strategic plan to engage new partners. The majority of the time was spent looking at Increasing Access to Healthcare and Healthy Foods Working Group Subgoal D. The group decided to make some adjustments to ITS logic model after reviewing Subgoal D. These changes are captured below.

Subgoal 3a: Make safety everyone's priority (residents, businesses, schools) through Community events and the use of technology to engage residents and inform community policing, restorative justice, culturally response and trauma-informed approaches.

Organizations added: Probation and Law enforcement Changes made to activities:

• Educate the community on the Get It Done app was removed.

Changes made to outputs:

• Increase residents' use of Get It Done app in the SDPZ.

Subgoal 3b: Advocate for infrastructure improvements (e.g., wider sidewalks and better lighting) that deter crime and improve the quality of community amenities, making the SDPZ a safer place to live, play and work

Organizations added: Probation and Law enforcement Changes made to activities:

• Added: Educate the community on the Get It Done app to promote infrastructure improvements.

Changes made to outputs:

• Increase residents' use of Get It Done app in the SDPZ by X%.
