MOTION: It was moved/seconded (K. McDonald/D. Rourke) to approve the Minutes from the December 3, 2019 meeting. Motion passed unanimously 4–0–0.

CHAIRPERSONS REPORT: None. Kelly McDonald applauded City staff for excellent work on Ocean Air's field renovation and brought up a need to have Torrey Hills fields renovated.

AREA MANAGER:

Debbie Marcotte, Area Manager reported that Ocean Air and Carmel Valley Recreation Centers will soon have permanent Assistant Center Directors, Carmel Valley is hosting a drive through Halloween event on 10/27/21 from 4-5:30pm, Carmel Valley has a new Center Director III (Mike Mangarelli) who will reach out to user groups and begin field allocation process for the Spring 2022 season.

RECREATION CENTER DIRECTOR:

Center Director Joe Monsour reported the new hours of operation of Ocean Air are Monday 10-7pm, Tuesday 9-8pm, Wednesday 9-9pm, Thursday 10-9pm, Friday 10-9pm, Saturday 9-3pm, Sunday Closed. The City mask guidance policy: For individuals fully vaccinated against COVID-19 it is recommended to wear a face covering when indoors; for individuals not fully vaccinated against COVID-19 it is required for them to wear a face covering. The open play schedules are showing signs of success with around 2,500 participants per month. The 2 Summer Movie in the Parks events Ocean Air hosted in 2021, 1 event at Ocean Air and the other event at Sage Canyon. Both movie events were successful with about 130 participants. The Snow Day event is scheduled December 4th, 2021 from 8:30-11:30am. Ocean Air field renovation was a success.

ACTION ITEMS:

Change CRG Advisory Meetings to meet quarterly

It was moved/seconded (Dan O' Rourke/ K. McDonald) to change meetings to meet quarterly on the 4th Tuesday of January, April, July and October. Motion passed unanimously 4-0-0.

Unfunded park improvements 2021

It was moved/seconded (T. Humes/ S.Harkin) to approve the budget with a proposal to add grass for the undeveloped area at Torrey Hills. Motion passed unanimously 5-0-0.

FY 23 RCF Budget

It was moved/seconded (T. Humes/ D. O'Rourke) to approve the budget with a proposal to increase the maintenance budget by \$20,000. Motion passed unanimously 5-0-0.

INFORMATION ITEMS:

-Discuss future field renovation projects. S. Harkin expressed concern for gopher eradication. D. Marcotte said she would investigate how City staff can help. T. Humes inquired about the liability. D. Marcotte explained if coaches deem a field unplayable they should not play on the field.
