PARTICIPATORY SCENARIO PLANNING





A community plan is a public document which contains specific proposals for future land uses and public improvements in a given community. A community plan is part of the City's General Plan. It provides tailored policies and a long-range physical development guide for elected officials and citizens engaged in community development.

WHAT THE COMMUNITY PLAN DOES NOT DO


- It does not mandate growth. The community plan provides options and opportunities for new housing and employment. It does not require property owners to redevelop or mandate that development will happen.
- It is not a maintenance document. The community plan is a long-range policy and regulatory document that identifies future infrastructure needs. It is not a plan to address the deferred maintenance of existing infrastructure.
- It does not approve specific projects. The community plan establishes policy and regulatory direction—all future projects will still go through an approval process

WHAT THE COMMUNITY PLAN DOES DO

- It provides community-specific, tailored policies and a long-range physical development guide for City staff, decisionmakers, property owners, and citizens engaged in community development.
- It establishes goals and policies to address land use, mobility, urban design, parks, open space, and public facilities.
- As a component of the City of San Diego's General Plan, it is a longterm blueprint for the future and provides location-based policies and recommendations.

Survey Comments 1

You need to make sure any changes you make address traffic and congestion. Any shopping areas should have signals at entrances and exits to the parking lots. Homelessness resources or enforcement of existing laws regarding vagrancy need to be addressed. I can't take my child to the park due to the encampments of people with trauma, substance abuse, and other mental health issues who live there. They're in poor health and need to either be helped or encouraged to move elsewhere. Just leaving the situation as it is harms them and our community.

Would like to promote tech industries and parks but always want to ensure better public transportation to reduce traffic on Mira Mesa boulevard. Mira Mesa center can have more businesses and house but would not prefer full urbanization.

With all due respect, I feel that building an additional housing community in Camino Santa Fe and Carroll Canyon Road will only increase traffic and frustration for those who live in Mira Mesa already.

Where's the 'none of the above' choice for each focus area? This gives the false impression that one wants a selection, when the truth is they don't any of them.

The less housing you choose, the less icons you get for 'parks' and 'investment'. I call these subjective metrics. Can you please leave the survey with objective metrics?

Investments to me: fairly close parking that's quick to get in and out of, and always getting free flowing roads to these places.

Parks to me: area.

Whatever you decide to do, make sure you take measure to reduce or control traffic. Things like Synced Traffic lights and longer green lights etc etc

Whatever happens, please make sure it doesn't take 30 minutes to travel from the 805 to the 15

We've owned our home here for over twenty years. Traffic is absolutely terrible and only getting worse. It is not possible to "improve" Mira Mesa until and unless you do some more work on the traffic flow patterns and especially limit the number of high occupancy resident buildings such as apartments and condos.

We need to remain as an industrial park; we do not want mixed-use areas within existing permitted industrial parks; it does not work well when you have families living in an industrial park.

We need to make a serious bid to get Mira Mesa connected to the light rail in UTC and a light rail option on the 15 corridor to make these higher density options viable long term. Rapid busses do not replace or approximate light rail use.

We need more transit options near Camino Santa Fe

We need more parks and places to socialize.

We need more jobs and housing!

We need more jobs and businesses.

Not housing. Mira Mesa, Miramar, and Sorrento is already overcrowded and traffic congested. We need more of the locals to work locally and reduce traffic and open up parking. More housing in an already congested area means more traffic, noise, requirements for infrastructure, increased demand for public services (fire, police, medical), more stress on already poorly funded schools, parks, and libraries, and all that would mean higher taxes for everyone. No more housing in Mira Mesa!!!!

We need Carroll canyon road to connect from the 15 to the 805. We need to fix the traffic crisis on Mira Mesa Blvd before adding or do anything else!!!! Please please extend Carroll canyon road first. Traffic is horrendous here!!! We need 3.5 MILLION homes. Please build more housing. I love my property value increasing, but more and more of my friends are moving AWAY

We have lived here nearly 50 years, and while I have long hoped for improved bus/transit access, I have great concerns about removing parking at the most often used shopping areas, as this will limit the ability of both seniors and families with children to get to the store of their choosing. At my age, I do not plan to bike everywhere, and do not want to rely on a bus schedule to go to the store or a restaurant - to say nothing of trying to get my groceries home! Improvements are needed in Mira Mesa, and while some plans won't impact me much, I am especially concerned with limiting driving and parking in areas 1 and 2.

We don't need thousands more stuffed into our community, traffic is already terrible.

we don't need more density in Mira Mesa. We need improved parks and roads

We don't need anymore houses and businesses in Mira Mesa. Congested enough!!!! Some open space is NOT a bad thing!!!

Traffic in and around Mira Mesa is already terrible during business hours. Adding the amount of proposed housing would adversely effect our quality of living in Mira Mesa

This is all good, but Mira Mesa boulevard is a mess. What would be excellent is an elevated trolley over the stretch from the Coaster station all the way to the 15 to alleviate traffic and ease the commute to Sorrento Mesa.

There were focus areas with more parks AND more housing. That makes no sense. Don't tell me you're using this new park 'point' system rather than park area. Rolling out small strips of grass and calling it a park is just wrong. Also this survey is missing a traffic column where more houses = more traffic. The 'investment' column's sole purpose appears to be just to sway the users choices to those favored by those whom made the survey.

There needs to be a 4 way stop/walk at MM Blvd and Camino Ruiz Blvd before and after school. It's a very dangerous intersection for all. Please consider a pedestrian walkway there and near the high school (Marauder Way over MM Blvd).

There is a severe lack of housing in the city, massive development in Mira Mesa is critical to bring housing levels back to normal. Increasing the amount of both jobs and houses in the area will reduce traffic throughout the county. I am all for massive development of Mira Mesa and I am looking to move into the area in the next few years.

There is a lot of traffic as is on Mira Mesa blvd. adding more housing would be a nightmare. How bout fixing all the terrible neighborhood streets filled with potholes first!

The outlined "park space" in these plans are not real park space. It is just small grassy areas next to the planned businesses, they would not be suitable for families, children or event gatherings.

The future is exciting! Hopefully commercial property will still be as useful post covid-19

The Community Plan Update should also include a review of the exisiting public realm throughout the community for needed upgrades to streetscapes, opportunities for better pedestrian connections, and other new planning concepts to revitalize the community experience. Hopefully, the update allows for similar opportunities for revised planning and mixed-use concepts beyond these few study areas. This is a great start, but much more can be done when looking at the community as a whole and thinking about great spaces and placemaking throughout.

The changes for Mira Mesa should be suitable for those that want to live there in the long term.

The best thing for this community would be to add a green belt of some sorts, where people can bike and walk without being afraid for their lives because of cars going super fast right next to them. It would be good to also have a shopping mall nearby that has nicer stores and better restaurants, not 5 fried chicken places and all of them fast food. I would love to see this area spruced up a little bit, it just looks so old.

The area is sufficiently populated now and any additional housing other than what has already been approved and in the works will lead to over crowding. Improvements can be made to improve the quality of life in Mira Mesa, but they should focus on better roads and traffic flow, and additional parks and recreational activities.

Please! No more housing! We're already overcrowded, and traffic can be terrible. That monstrosity by the 15 freeway is an eyesore and the extra people have negatively impacted the area. I've lived here since 1982 and, while I know we can never go back to the way it was, I don't want to see it get worse. Put money into beautifying what is already here, and maybe have an artificial grass fund to eliminate all the brown lawns that make neighborhoods unattractive. And we're still waiting for that community pool that was promised years ago.

Please STOP the high density plans for Mira Mesa.

Fix the damn roads!

Please stop any more housing developments, it's already too congested in Mira Mesa. The streets are in need of maintenance.

Please re-pave our busiest roads and improve traffic lights and patterns. It takes so long to get around via car in Mira Mesa, and I would love to see better bike lanes.

Please prevent over populating this area. Quality of life will suffer

Please ensure that Little India in the Miramar Gateway sector is preserved as a community asset.

Please don't make traffic worst nor increase tax. Thanks!

Please don't price out all the ethnic grocers and businesses. Feel free to throw tons of money at tech.

Please also fix the roads. The roads in Mira Mesa are seriously neglected. I have decided to move away from Mira Mesa because the neighborhood was not walkable or scenic, so I am glad to see this is being addressed.

Plans need to address already problematic traffic

People should be asked for their address, since anyone can say they live in Mira Mesa. People are filling out this survey multiple times and saying they live in Mira Mesa when they don't.

Our community is concerned that people outside of Mira Mesa are voting for the options with the highest amount of development in hopes that their neighborhoods will have lower ones in their plans.

And that people who support developers will also vote for higher densities.

PARKING AS WE EXPAND

Owner of the recreation facility in Mira Mesa, the San Diego Ice Arena

Our family would like to beautify Mira Mesa. We are concerned about the cities effort to prevent Mira Mesa from becoming a homeless encampment. We would like events to be held for local residents, seniors citizens, and especially families with young children. We do not support housing for low income. We would like the city to develop public spaces such as parks or public recreation centers.

Our (Mira Mesa) roads are bad enough with the population we have. It takes a long time for us in the center of Mira Mesa to access freeways 5, 805 and 15, double that time during rush hour. I hope the City of San Diego's planning committee takes into perspective post-pandemic life (people working from home, online shopping, the already outrageous taxes by the State) before investing so much into and already over populated community. I believe Sections 1 and 2 should remain the same. Part 3, Camino Santa Fe should not be changed but the western parts of 3 should be built up to encourage large tech companies which will offer employment to San Diegans. Rather than so much new development, I would like to ask the planning commission to build high speed mass transit that run to key points of the city (UTC, Scripps Hospital complex, Sea World etc etc) to help alleviate traffic and parking issues. Please DO NOT add more people to Mira Mesa.

There are not many enclosed activities in Mira Mesa except for the ice skating rink and not everyone can use the skating rink. Everyone is focusing on parks which are fine, but nothing like the bowling alley... if they can survive COVID. Please keep this in consideration when tearing down existing businesses.

No new developments in Mira Mesa. There's too much density with a lack of transportation infrastructure. Our neighborhood roads are not maintained and will just turn into dangerous shortcuts for commuters. Who wants to live in a neighborhood with traffic control (speed bumps, turnabouts, etc.). SANDAG and the city wasted money on unused bike lanes. Multiunit housing us not really solving the housing market by creating overpriced rentals. We need more single family homes that are primary residents instead of apartments and condos. Owners have more interests in the communities they live in than renters. Say no to short term rentals in our community. You're not improving the lives of longtime residents and interested in investing in us.

No more new housing in Mira Mesa. It's becoming overcrowded here.

No more multi-level housing like Casa Mira View! Way too many people in Mira Mesa already.

Mira Mesa is an already gridlocked area in traffic. The traffic is so bad it's sometimes hard to change lanes and often take upwards to 20 minutes to go from one part of Mira Mesa to the other. Also, several of the strip malls set to be demolished for development are still frequently used by the public and would harm the families who own restaurants within them. I personally support more tech companies in Sorrento Valley, but addition of more tech companies also drives up rent and cost of living. I firmly believe the Mira Mesa, Miramar and Sorrento Valley area could use a facelift, but increasing its residential density should only be done in moderation. I also believe a Trolley extension would serve this area well.

Mira Mesa is already so overcrowded. We don't need more housing.

Mira Mesa has seen an exponential increase in visitation (and subsequent traffic) from people that live outside of the town, due to the increasing number of popular businesses that have set their roots here. I would personally like to see more proposals for improving transportation flow and road quality that will be able to withstand the volume of people flowing in and out of Mira Mesa as it grows even more.

Mira Mesa Gateway: I like scenario 2 for the bridge and park additions, but would like to preserve or relocate Barnes and Noble and Best Buy.

Mira Mesa Town Center: I chose Option 1 because Option 2 replaces the parking in front of Vons with apartments, which is nuts. Without those apartments, I would prefer Option 2.

Sorrento Mesa: In general it is best to keep housing away from industrial. so Option 1 for Barnes Canyon. Housing makes more sense for Pacific Heights than for Barnes Canyon, but I like the design of Option 1 better for Pacific Heights.

Miramar Gateway. I like the Creek greenbelt in all 3 very much. I like Option 1 that has both residential and light industrial, separated, better than option 2 which is all housing. I know that the landowners prefer Option 3, but it is difficult to envision what that would really look like since all decisions are left for the future. For all scenarios, we need to preserve the Little India area, which is an important part of our community.

Mira Mesa Gateway - Like the bridge in Scenario 2, added park and increased walkability, but need to preserve Barnes & Noble as key MM business and community center, a hub where people meet to exchange ideas and socialize as well as purchase items. Keep building or relocate B & N within area! Also should retain Best Buy, another important business!

In western MM / Sorrento Mesa, must retain historic olive trees in landscaping around current industrial at Flanders & MM Boulevard! These were replanted from an old grove in area when that development was done. Keep for the future!

Mira Mesa Boulevard is already total gridlock during commuting hours. In the mornings, West bound traffic on Mira Mesa Boulevard completely fills the distance from Camino Santa Fe - West to Pacific Heights Blvd., and from there it is very tight to Hwy 805. There is no room for more vehicles wishing to travel North out of the proposed construction to travel West on Mira Mesa Boulevard. (Pre-Pandemic) West bound Mira Mesa Boulevard is already completely full in the mornings from Camino Santa Fe - West.

Adding housing units and businesses, with more vehicles providing more transportation for more people will degrade even further overloaded Mira Mesa Boulevard. Please do not add more congestion to this already jam packed area. It is already gridlock.

Mira Mesa and Sorrento Valley needs to become more densely populated where living close to work is possible. This needs to be supported by having viable alternative transportation other than low occupancy cars. Add protected bike lanes and dedicated bus lanes. If possible get a light rail (MTS) into the heart of the major working hub in Sorrento Valley.

Lovely to see parks/greenery being considered! The greener, the better.

Also VHFHSZ and planning & development that enhances our ability as a community to prevent and address the potential for a wildfire in the area especially the canyons

It would be great to have places to live and things to do near Miramar College that better serve the college students. We have to drive long distances to get there and there is nothing to do around there, except for a few places. It would be great to have more restaurants and also places to live, similar to what is being built in Mission Valley, for younger people. There are great places to work in Sorrento Valley and Miramar is a great college, but the part in between is not so great.

Is the survey weighted by how long residents will continue to live here? I don't want the retired folks who live here now dictating what I am going to have to live with.

Investment and bringing more opportunities to Mira Mesa. Mira Mesa is a very central location and an awesome town.

Invest in attracting more tech companies into Mira Mesa. We are setup well for expansion and could make this city into a great SoCal tech hub.

Intensify everywhere, but fix Gold Coast and Mira Mesa BLVD so they are safe for pedestrians and cyclists.

In order to satisfy demand for accessible housing, we need to give property owners the financial incentive to replace existing commercial industrial and retail space with mixed use and flexible projects. It is very important for all of the stakeholders to understand the economics of the proposed rezoning to see if it is economically beneficial for all stakeholders. Of course, we also need to understand how this would change the standard of living and accessibility for the existing businesses and residents. I believe we can come up with a win-win solution for all parties involved with the right input and data from qualified experts. As of now, we are missing input from a qualified builder/developer that understands the economics of rezoning existing projects.

If I wanted to live in an urban environment I would have moved downtown. Your plans would eliminate the building where I work and my supermarket that I can currently walk to, forcing me to drive farther to go shopping. Adding more jobs and more housing won't cause people to drive less. Mira Mesa Blvd is already jam-packed at rush hour. It will only get worse. As for parking lots, they are necessary for people going shopping. No one will take a bus to go grocery shopping - they can't take the groceries home with them. Cars are necessary. Instead of adding more buildings, why don't we resurface Gold Coast and add a few parks? There are few parks in Mira Mesa.

If housing means "condos" or "townhomes" with ridiculous HOA then hell no. Don't think \$300 a month is okay because it's not.

I think the second development area (where the Target is) needs to be the focus of improvement, especially the Epicentre (former Harmonium owned teen center) I worked there for five years as a young adult and it is sad that it is just sitting there unused. I would hate for it to be torn down; is there any way it can become a teen center again? It was such a positive environment; a place where teens could gather, do homework, learn skills, get work experience. I don't think the positive impact the Epicentre had on so many people, including me, was ever truly known by community leaders. Please re-open this building and put something worthy and deserving of its legacy in it.

I think that if all of the focus areas are built, there will be too many new residents and too many more cars on MM Blvd. I don't believe people will give up their cars. I think more home areas should be built in the 2 westernmost Sorrento subareas where the transit options are the best and the businesses are located. If people don't ride transit, what is your plan for improving traffic along MM Blvd? I don't like that we have to approve any of these options. We will already have too many new homes with 3Roots and Stone Creek. My vote is no on focus areas 1 and 2.

I think that affordable housing and Increased availability for transit need to be the focus on continuing to develop our community.

I have worked in the tech field for a number of years. More investment in Mira Mesa would be beneficial to offer more places to live and more restaurants and other businesses. Mira Mesa could use a fresh look and it would become a more desirable area.

I have lived in Sorrento Valley for over 25 years and would like to see the 3 neighborhoods represented on the next CPU. Mira Mesa, Sorrento Valley and Mira Mar. It is very important to showcase the uniqueness of each neighborhood.

I have lived in Mira Mesa my whole life and I love it here but we do not need more housing. Examine consistency throughout the Mira Mesa Community; Given the time frame for these changes, their impact on the older parts of Mira Mesa need to be included. For example, changes in older single family houses, decrease in value of these older houses and their possible attractiveness for lower income residents.

Due to the likely permanent shift from corporate office to work from home for many tech companies in Sorrento Valley/Sorrento Mesa it would be wise to begin consideration of a shift in this area away from commercial office real estate to medium density housing. This shift to permanent corporate wfh will likely take 2-5 years as companies recognize the financial benefits. This will give city planners time to re-evaluate zoning and real estate use in these areas.

dont you think 80000 people living in this area is enough?

Before spending a ton of money increasing density, I'd rather see Mira Mesa focus on keeping its roads paved and making itself even remotely bike friendly Because of all the traffic, the last thing Mira Mesa needs is more housing.

As someone who takes public transit, having a walking bridge in mira emsa would greatly benefit me. Housing closer to the Sorrento Valley workplaces as well as more housing in general would help drive down costs in the area.

As much as I appreciate the walkability of urban areas and opportunities for mixed use areas, I think it's important to maintain the suburban feel of our community.

Are traffic, infrastructure, road conditions, being addressed? Mira Mesa blvd is already crowded and community streets are already are not being maintained.

Anything that makes this community more walkable, and invests in more green public parks, is top priority in my book!

Any development must deal with the increasing homeless sleeping on our streets and building shelters in the canyons and large bushes. The problem is escalating and no seems to care or if they do nothing is done about it.

Also many rush hour commuters are using residential streets as opposed to the main traffic arteries, by doing so they are traveling above the residential speed limit and causing havoc for those of us who live on these routes that are being used instead of the main arteries. Traffic humps have been installed but are ignored; maybe more interceptions with full 4 way stops could deter these unfriendly commuters. All of these problems have too much RED tape.



Survey Comment 10

Although the plans look nice on paper, they are severely flawed.

The addition people (living or working) in Mira Mesa add more traffic. Mira Mesa Blvd, Miramar, Black Mountain, Kearny Villa are

through streets to other neighborhoods. The traffic and parking issues will be exacerbated. Currently it takes 10 minutes (on a good day) to 30 minutes (in traffic) to get out of MM.

All of these areas are over developed, with the exception of Miramar Gateway (4). MCAS Miramar is in dire need of workforce housing; their employees are supposed to live within a certain distance of the base but they are being forced to commute from outlying areas due to the cost of housing. There is NO housing along Miramar Rd; the nearest housing will eventually be built in Carroll Canyon. The Miramar Gateway area is prime for (1) workforce housing, and (2) flex zoning so that the business areas can adapt to the changing economy without paying tens of thousands of dollars in fees and going through months/years of process and hearing to change each parcel.

After taking a look at the DRAFT Community Plans for 3Roots and Stone Creek, I now want the housing to be almost ONLY happening in Carroll Canyon. The scenarios for Miramar and Sorrento Mesa focus areas, I prefer, to mainly focus on adding more jobs and parks/recreational areas. For the currently-existing residents, and the future ones, of course. I'd rather keep most of our stores we still have so Mira Mesa doesn't look so different. However, redesigns for most of the commercial centers are needed to make parking and traffic more optimally efficient.

P.s. the third scenarios for the two focus areas in Mira Mesa should replace the mixed-use, palazzo-style buildings with mostly commercial space for small businesses. I want local entrepreneurs to grow numerous and prosperous in my town. Affordable housing that the minimum wage earner can afford. Cafes, and cultural venues, public transportation, pedestrian safety.

A couple of the Miramar plans essentially pave over my church. A community with hundreds of people that has gone back multiple generations. Not cool.

A balanced approach is best. Living just north of these areas I shop and use the resources of this area extensively for entertainment and the necessities of life. The recent development of massive apartment buildings on Westview Ave makes me wonder on the planning and zoning process as schools and parks have not increased.

21 year Mira Mesa resident looking forward to a denser, more liveable Mira Mesa, with a focus on affordability and housing. Also, more public transit would be a dream come true!

- * Taking away parking and store space from retail centers may create a "green" appearance, but it also harms the people in the community who are not fortunate enough to live in the adjacent housing and still need to drive in.
- * Converting existing retail space to mixed retail and residential can force out affordable stores, once again harming the community. What will be done to prevent this from happening?

These planning proposals are nice, but what Mira Mesa needs *most* is a good mass transit system East / West to reduce traffic on Mira Mesa Blvd. I realize I am probably talking to the wrong department.

I know housing density is important, but please do not reduce the amount of commercial property to achieve this in Mira Mesa. We need the little we have. Simple auto parts stores etc. are really important.

I thing there is a lot of potential in building residential up. I don't think many current residents in Mira Mesa would approve of more than 5 floors. Don't even think about increasing density without incorporating a good mass transit system. The recent bus hub at Miramar College is nice, but a bus is going no where in the Mira Mesa Blvd. traffic.
