Meeting Notes

Brief Review of September Working Group Meeting

The working group reviewed the outputs and outcomes for each subgoal, linking back activities and inputs. There was discussion about the organizations that are doing work in the Promise Zone, coming around the table and involving partners. The goal is that the logic model should be reflective of the efforts of the group as a whole.

Community Meeting list

The group was given a community meeting list, bringing to light the following issues: Go back and think about what the original intent was for community meeting list; what the different methods of engagement are and standardized messaging. We will come back to this. Circulate to the different groups.

- Community Planning Committees: How do we measure increased attendance/participation? Get attendance numbers from established groups.

Review of the Revised Creating a Priority of Safety Logic Model

A revised logic model was shared with the group. It included revisions from the September meeting. The group was invited to review it closely and determine if all the appropriate partners were listed in the inputs column. During the meeting, several organizations were added to the inputs column while activities and outputs were revised in the logic model.

Subgoal 3a: Make safety everyone's priority (residents, businesses, schools) through community events and the use of technology to engage residents and inform community policing, restorative justice, culturally-response and trauma-informed approaches.

Inputs added by the group: CBOs, faith-based partners, businesses, civic organizations, schools and libraries.

Changes made to activities:

- Disseminate information related to safety through faith-based partners, businesses, San Diego Police Department, schools and other community partners.

- Use community policing strategies (e.g., walk-and-knocks, community fairs, community events, captain advisory boards, posting to Nextdoor).

Changes made to outputs: Increase community participation in *community meetings*

Subgoal 3b: Advocate for infrastructure improvements (e.g., wider sidewalks and better lighting) that deter crime and improve the quality of community amenities, making the SDPZ a safer place to live, play and work

Inputs added by group: CBOs, faith-based partners, businesses, civic organizations, schools and libraries, City of San Diego Park and Recreation, County of SD

Changes made to Activities: Build relationships with SDPZ businesses to implement CPTED (Crime Prevention Through Environmental Design) [Cross threads with Economic Activities group].

Changes made to outputs:

- Number of contacts with SDPZ businesses that implement CPTED
