Effective January 9, 2019, the new cycle of Advanced Officer Training (A.O.T.) 2019-2020 will begin. The training classes will run until the end of 2020, with the exception of summer months (June, July and August). All sworn personnel from the rank of Sergeant and below shall attend A.O.T. during this training cycle.

P.O.S.T. requires that all sworn officers complete a minimum of 24 hours of Continuing Professional Training (C.P.T.) every two years. A.O.T. satisfies the P.O.S.T. requirement for Sergeant and below and will keep them in compliance. All sworn personnel from the rank of Lieutenant and above shall attend a minimum of 24 hours of a P.O.S.T. approved course to meet the compliance requirement within this two-year training cycle. Effective January 3, 2019, enrollment in A.O.T. will be done through Success Factors, which can be accessed through the OneSD Portal.

Failure to attend A.O.T. /C.P.T. during the 2019-2020 training cycle will result in non-compliance with P.O.S.T. mandated training and can result in disciplinary action by the Department.

Personnel must be full duty status to attend A.O.T. and must have all required equipment with them to participate.

The schedule for the 2019-2020 A.O.T. cycle covers the minimum MANDATORY items (by statute, P.O.S.T. regulations, and legislation). These mandatory courses can be done during one continuous course (i.e., A.O.T.) or completed as standalone courses so long as each mandatory component is covered during a 2 year period. Each component must be completed to remain in compliance with P.O.S.T. Continue Profession Training (C.P.T.) standards. The proposed schedule above includes the following mandated courses:

P.O.S.T. Perishable Skills Program Training (required each 2 year C.P.T. cycle – 14 hours)

- Firearms Training (4 hours)
- EVOC Training (4 hours)
- DETAC Training (4 hours)
- Tactical Communications Training (2 hours)

First Aid / CPR refresher training (required to be completed every 2 years – 8 hours) must include lecture (classroom or video) and practical skills. The refresher can be done as part of C.P.T. but may be done as a standalone course.

Mental Health (required to be completed every 2 years – 3 hours) is mandated every 2 years per SB 11 and SB 29. This course must be held in a classroom and instructor lead.

Domestic Violence update training (required to be completed every 2 years – 2 hours) per PC 13519 (g) and POST REGULATION 1081.

All P.O.S.T. perishable skills program training is presented in a regional training format. Attendees should refer to their department policies and procedures for specific guidelines in all areas of training, including but not limited to Defensive Tactics, Use of Force, Emergency Vehicle Operations and Firearms.
