- I. <u>Call to Order</u> Commissioner Ann Bossler called the City of San Diego (City) Commission for Arts and Culture's Policy & Funding Committee to order at 8:32 am in the City Council Committee Room, 12<sup>th</sup> Floor, City Administration Building, 202 C Street, San Diego, California 92101.
- II. Chair's Reports
  - D. <u>ACTION September 13, 2019 Policy and Funding Committee Meeting Minutes</u> Commissioner Bossler called for a motion to approve the Policy & Funding Committee meeting minutes of September 13, 2019. The motion was seconded. The vote was 4-0-0; the motion passed.

#### III. Arts and Culture Funding

- A. <u>Presentation Arts Impact Mapping</u> Christine Jones, Chief of Civic Art Strategies, gave an informational presentation on an initiative to aggregate and visualize data gathered from FY19 city-funded Organizational Support Program and Creative Communities San Diego organizations through an interactive map. Jones and Arts and Culture Project Manager, Karla Centeno walked Commissioners through the data tools in the map, such as identifying organizational hubs, venues where organizations perform services, insight tabs for organizations and venues, council district data summaries and plans to continue finessing data and mapping tools for a public launch. Commissioners lauded the efforts of staff to create a data imaging tool that will serve as an advocacy tool and aid organizations and the City alike in trends and gaps.
- B. <u>Presentation Arts Education Enrichment Initiative Assessment</u> Arts and Culture Project Manager, Karla Centeno gave an informational presentation on the results of impact data collected over the last 3 years on the Arts Education Enrichment Initiative. Centeno gave Commissioners a brief historical analysis on the Initiative, sharing that in 2014 the

Commission's ad hoc Arts Education Advisory Committee made a recommendation to allocate \$100,000 in funding for arts education. In FY15 staff recommended that the \$100,000 in funding for arts education be awarded as a contract augmentation to Young Audiences of San Diego to augment a \$3.5 million dollar federal funding allocation to launch the San Diego Unified School District's Title 1 Arts Learning Initiative. The allocation was repeated in FY16 and increased to \$147,244 in FY17. In 2017, the City reevaluated the allocation of funds to a single recipient in order to increase access, equity and impact and instead reallocated and increased the funds from \$100,000 to \$220,000 to create the Arts Education Enrichment Initiative (AEEI). AEEI allocated \$220,000 to 11 contractors in 2018, \$100,000 to 10 contractors in FY19 and \$80,000 to 8 contractors in FY20. Centeno presented impact data that included number of schools served over the last 3 fiscal years, number of students, number of proposals received, number of projects, number of artists engaged and number of Council Districts served. Also presented were challenges associated with the funding opportunity due to timing and access to resources. Staff indicated that the majority of the schools and sites being served through AEEI programs are already being served through multiple organizations who receive Organizational Support Program and Creative Communities San Diego funding and so the efforts and impact of AEEI may be duplicative. Commissioners responded with insights regarding return on investment and applauded the efforts of staff to assess the impact of AEEI and its shortfalls.

<u>Public Comment</u> – Peter Comisky thanked staff for the tremendous accomplishment and potential of the arts impact map and encouraged staff to continue with its efforts, as they will be a great tool for arts advocacy.

- IV. <u>Staff Reports</u> Interim Senior Arts and Culture Funding Manager, Leticia Gomez Franco gave a brief reporting on the status of the funding program, stating that FY19 contractors are submitting their financial disclosures as stated in their contract, FY20 contracting has exceeded prior years, with over 90% of contracts being routed and issued purchase orders, meaning contractors can focus on fulfilling their scope of service. FY21 is currently in application phase, with requests for qualification cures wrapping up and staff getting ready to release the Request for Proposals(RFP) January 6<sup>th</sup> and begin with a full schedule of technical assistance workshops and office hours. RFP's are due February 7<sup>th</sup>. Gomez Franco also reported that the deadline to apply for Commission Advisory Panel service has been extended to January 10<sup>th</sup> and reminded Commissioners to spread the word and forward any potential nominees to her for follow-up.

#### STAFF RECOMMENDATION

Recommend that the City of San Diego Commission for Arts and Culture (Commission) recommend to the City of San Diego Mayor and City Council the Request for Proposal ranks for Fiscal Year 2021 Organizational Support Program and Creative Communities San Diego funding categories, as submitted by Commission Advisory Panels.

#### SUMMARY

The City of San Diego (City) issued the Request for Qualifications (RFQ) for FY21 Organizational Support Program (OSP) and Creative Communities San Diego (CCSD) funding categories on September 16, 2019.

One hundred eighty (182) nonprofit organizations submitted an application in response to the RFQ. Of those applicants, one hundred seventy-six (176) were deemed financially qualified to hold a contract with the City and invited to submit a proposal in response to the Request for Proposal (RFP).

All qualified first-time applicants, eighteen (18) in total, were required to submit a proposal. Qualified applicants under contract with the City for FY20 OSP and CCSD funding were able to select between submitting a proposal and requesting that the City exercise the Option to Renew their agreement.

The value to an existing OSP or CCSD contract holder in submitting a proposal is that the organization can update or refine organizational details such as program details and compete for a higher score than achieved in the past.

In total, sixty-seven (67) eligible proposals were submitted in response to the RFP and one-hundredone (101) applicants requested and were granted the Option to Renew. Organizations who were granted the Option to Renew retain their ratified rank from the previous year.

In January 2020, the Commission appointed Commission Advisory Panels (CAP) to participate in the review of proposals received by the City for the Fiscal Year 2021 OSP and CCSD funding categories. Over a one-week period, CAPs convened in four separate public meetings. Each panel evaluated a specific group of proposals using standard criteria and scoring. The panels also included a process allowing applicants to address the panel at two prescribed intervals – prior to and following the panel discussion of each applicant's proposal. After evaluation of all proposals and scoring, each CAP voted to recommend ranks for their specific group of proposals. The lists included with this report show all qualified applicants, including the recommended ranks provided by the Fiscal Year 2021 CAPs and ranks retained by applicants who were granted the Option to Renew.

#### NEXT STEPS

Following Policy & Funding Committee's recommendation, the Commission will receive and vote to recommend the RFP ranks to the Mayor and City Council. Commission staff will use recommended ranks as one factor in the calculation of each applicant's contract award amount. Using the standard award algorithm as stated in the Fiscal Year 2021 OSP Funding Guidelines and Fiscal Year 2021 CCSD Funding Guidelines, any organization who received a rank of 2+ or bellow, will not be recommended for funding. Tentative award amounts will be publicized as they are available, and final award amounts will be announced by June 30, 2020, all contingent on available funds in the adopted FY21 City Budget.
