- B. Public Art Commissioner Vernon Franck, Chair of the Public Art Committee, reported that here comes the neighborhood, was featured in the UT's year—end round—up of most compelling visual art projects of 2017. He also reported that on Friday, February 16, the City of San Diego and Civic San Diego will be celebrating the completion of construction of Southcrest Trails Neighborhood Park and the permanent artwork integrated into the park by Ingram Ober and Marisol Rendon—Ober.
