STAFF RECOMMENDATION:

Advise the City of San Diego (City) Commission for Arts and Culture (Commission) to recommend the following panelists for the Beyer Park Public Art Project: 1) one Public Art Committee member, plus one alternate member; 2) Francisco Morales for the seat of the Visual Art/Design Professional with recommended alternates, in no particular order, to serve as two of the five ad hoc artist selection panelists.

SUMMARY:

City staff will administer the artist selection process related to the upcoming public art project for Beyer Park. The artist selected for the project through the competitive process will work with the City and the design/build team to create a permanent, site-specific artwork for the park. Artwork can be incorporated into the construction project in many ways and there are a variety of possible approaches to artmaking. The anticipated artist budget for the public art project is approximately \$170,000. The public art project is funded by the City as set forth in City Council Policy 900-11 - Inclusion of Public Art in Selected Capital Improvements program Projects.

The artist selection panel will be composed of five voting members: one member of the Commission's Public Art Committee, a visual art/design professional, a community member, a client department representative and the City's design consultant. City staff members will attend the panel meetings as non-voting advisors. The Public Art Committee is authorized to make recommendations for the appointment of two of the five panel seats for the public art project.

Francisco Morales is an artist and gallery director Casa Familiar's art and culture center, The FRONT, in San Ysidro. In addition to his roll at The FRONT, Morales creates electroacoustic compositions, multimedia installations, interventions & performances that immerse the audience into a world rich in symbols and poetics. His works have been presented in México, United States, England, Spain, France, Italy, Czech Republic, Canada, Colombia, Argentina and El Salvador in festivals such as San Francisco Tape Music Festival, New York Electroacoustic Music Festival, Festival TransitioMX, InSOnora, among others.

STAFF RECOMMENDATION:

Advise the City of San Diego (City) Commission for Arts and Culture (Commission) to recommend the following panelists for the *here comes the neighborhood* – *Encanto* Public Art Project: 1) one Public Art Committee member with recommended Public Art Committee member alternate, 2) Roman de Salvo for the seat of the Visual Art/Design Professional #1, 3) Lani Bautista Cabanilla for the seat of the Visual Art/Design Professional #2 with recommended alternates, in no particular order, to serve as three of the five ad hoc artist selection panelists.

SUMMARY:

City staff will administer the artist selection process for *here comes the neighborhood* public art initiative. The artists selected for the second iteration of *here comes the neighborhood* through the competitive process will work with the City to create permanent, visually engaging and conceptually rich artworks for the Encanto neighborhoods. Up to three artists will be commissioned. The anticipated artist fee for each artist in the second iteration is approximately \$35,000.

In alignment with *here comes the neighborhood* project plan, the artist selection panel for the second iteration will be composed of five voting members: a Public Art Committee member, two visual art/design professionals, a Planning Department representative, and a community representative, City staff members will attend the panel meetings as non-voting advisors. The Public Art Committee is authorized to recommend appointment of three of the five panel seats for the public art project.

Roman de Salvo, Artist

Roman de Salvo is a San Diego-based conceptual artist who works in both sculpture and installation, infusing the ordinary with surprise and poetry. Much of de Salvo's work is site-specific, and he has contributed temporary and permanent installations to the San Francisco Art Commission Gallery, inSITE'94 at the San Diego Natural History Museum, 96 Containers in Copenhagen, Caltrans District 11 Headquarters, San Diego, the New Children's Museum, San Diego, and the Museum of Contemporary Art San Diego. His projects often transform vernacular objects into artworks of poignant humor. He has exhibited in institutions and galleries across the country and has work in several museum collections. He received his BFA from the California College of Arts and Crafts and MFA from the University of California, San Diego. Roman is a resident of Encanto and previously served on the Encanto Neighborhoods Planning Group (now called the Chollas Valley Community Planning Group).

Lani Bautista Cabanilla, Manager, Community Impact, The San Diego Foundation

Lani Bautista Cabanilla is an arts administrator and community organizer with over 15 years of experience serving the arts and culture field. She was recently appointed as a Manager of Community Impact at The San Diego

Foundation. Prior to that, she served as Senior Manager, Programs at The New Children's Museum in San Diego, where she collaborated with artists and community partners to develop innovative projects and installations that welcome over 250,000 children and families annually. In the last decade, Cabanilla has created arts education programs for five thematic exhibitions and curated dozens of hands-on studio experiences. Prior to joining the museum in 2008, she worked in community-based education programs, at independent design firms and on set-design projects in Los Angeles. Cabanilla has a BA in Art from San Diego State University, an AA in Visual Communications from The Fashion Institute of Design & Merchandising and studied Human-Centered Design at The Design Academy. She also serves as a Board Member and Managing Director for Made in Paradise Hills - PH Night Market in Southeast San Diego.
