

Instructions to Voters

If you desire to vote in favor of the annexation of La Mesa Heights to The City of San Diego, stamp a cross (X) in the voting square at the right of and opposite the word "Yes," which is in the square at the right of the first proposition. If you desire to vote against such annexation, stamp a cross (X) in the square at the right of and opposite the word "No," which is in the square at the right of the second proposition. All marks except the cross (X) are forbidden. All distinguishing marks or erasures are forbidden and make the ballot void. If you wrongly, stamp, tear or deface this ballot, return it to the inspector of election and obtain another.
