Proposition I. Shall The City of San Diego incur a bonded indebtedness of \$650,000.00 for the acquisition, construction and completion of a Municipal Air Port on the tide lands of the Bay of San Diego, between Laurel Street and the U. S. Marine Base?

Proposition II. Shall The City of San Diego incur a bonded indebtedness of \$200,000.00 for the acquisition, construction and completion of an addition and extension of the Broadway Pier, to the Pierhead Line, including a shed, elevated passenger walk, landing platforms, gangplanks and accessories thereon?

Proposition III. Shall The City of San Diego incur a bonded indebtedness of \$100,000.00 for the acquisition, construction and completion of the first unit of a Municipal Recreational Area at La Playa, in the City of San Diego, consisting of the dredging, bulkheading and filling in of a certain portion of Zone "G" of the tide lands at La Playa, in said City?

Proposition IV. Shall The City of San Diego incur a bonded indebtedness of \$65,000.00 for the acquisition, construction and completion of a municipal improvement on the tide lands of the Bay of San Diego, consisting of the paving of a portion of Belt Street, extending from approximately the foot of Columbia Street to approximately the foot of Eighth Street, and the paving of portions of Columbia Street, First Street, Third Street, Fifth Street and Eighth Street, from the southerly line of the Right-of-Way of the Atchison, Topeka & Santa Fe Railway Company to the southerly line of Harbor Street, together with the installation thereon and therein of storm drains?

Proposition V. Shall The City of San Diego incur a bonded indebtedness of \$50,000.00 for the acquisition, construction and completion of municipal improvements in the Bay of San Diego, consisting of the construction of 210 feet of concrete bulkhead in the Bay of San Diego between the south line of the Broadway Pier and the north line of the U. S. Navy Pier, and the filling in of the lands behind said bulkhead with dredged materials; also the paving of the unfinished portion of Harbor Street, from the north line of Municipal Pier No. 1 to the north line of the existing pavement at the wharf at the foot of E Street?

Proposition VI. Shall The City of San Diego incur a bonded indebtedness of \$54,000.00 for the acquisition, construction and completion of improvements in Balboa Park, in said City consisting of the paving of that certain road or highway therein contiguous to Sixth Street, otherwise known as Park Avenue, from Date Street to Upas Street, together with the construction of walls, curbs and sidewalks along the same; and the paving of that certain road or highway in Balboa Park, contiguous to Date Street, between Sixth Street and Ninth Street, together with the construction of curbs along the same?

Proposition VII. Shall The City of San Diego incur a bonded indebtedness of \$65,500.00 for the acquisition, construction and completion of a municipal improvement in Balboa Park, in said City consisting of the widening and improving of Pershing Drive in said Balboa Park, by the grading and paving of extensions thereto, and the construction of curbs, culverts and catch-basins thereon and therein, and the construction of an extension to the bridge therein?

Proposition VIII. Shall The City of San Diego incur a bonded indebtedness of \$150,000.00 for the improvement of Balboa Park, in said City, by the construction and installation therein of an eighteen-hole Golf Course, including the installation of a water system therefor, and the grassing of the fairways and greens thereon, and the construction of a municipal Club House thereon?
