SUBJECT:	Hilltop/Euclid Mixed-Use Development Project No. 560527, Planning Commission agenda for November 8, 2018.

Within the body of the deviation request No. 3 for the Minimum Lat Area, the lot area should have stated 1,197-sqaure-foot, not 1,1971-square foot. An extra one was erroneously added at the back of the number. The Resolutions and Permit have been corrected.

Correction in yellow below:

3. A deviation from <u>SDMC Table 131-04G</u> - Minimum Lot Area, to allow for reduced minimum lot area for the single-family dwelling units (2,170- through 3,431-square -foot lots) and townhomes lots (987- through 1,1971 1,197-square-foot lots), where a minimum 6,000 square feet is required for each lot within the RM-1-2 zone.


