### **CURRENT PLANNING COMMISSION DOCKETS AND BROWN ACT COMPLIANCE - COVID-19 PUBLIC SERVICE ANNOUNCEMENT REGARDING MEETING ACCESS AND PUBLIC COMMENT.**

Until further notice, Planning Commission meetings will be conducted pursuant to the provisions of California Government Code section 54953(e), added by Assembly Bill 361, which allows the Planning Commission to use teleconferencing and to provide the public an opportunity to address the Planning Commission via a call-in option or an internet-based service option, during a proclaimed state of emergency. On October 10, 2022, the San Diego City Council declared an existing proclaimed state of emergency and under amended Assembly 361 that their findings apply to all boards, commissions, and committees of the City of San Diego.

Members of the public in attendance at the Planning Commission meetings are encouraged to maintain social distancing in Chambers. Additionally, we are continuing to provide alternatives to in-person attendance for participating in Planning Commission meetings.

**ITEM 2: MIRA MESA COMMUNITY PLAN UPDATE**

**City Council District:** 6 **Plan Area:** Mira Mesa

**Staff:** Alex Frost

The Mira Mesa Community Plan Update is proposed to replace the 1992 Mira Mesa Community Plan and Local Coastal Program for the approximately 10,700-acre Mira Mesa Community Plan Area located between Marine Corps Air Station (MCAS) Miramar on the south and Los Peñasquitos Canyon open space on the north, and between Interstate 805 and Interstate 15. The Community Plan Update provides a comprehensive policy framework for future growth and development over the next 20 to 30 years. Consistent with the General Plan and the Climate Action Plan, the Community Plan Update proposes a land use strategy with additional capacity for employment and residential in Transit Priority Areas (TPAs). The Community Plan Update also includes policies to provide a multimodal transportation system to promote active transportation, increase transit use, and provide more connections in the community. The Community Plan Update proposes the use of the Community Plan Implementation Overlay Zone (CPIOZ) Type A to provide ministerial Supplemental Development Regulations to implement recreation, urban design, and mobility requirements in villages areas. The Community Plan Update also proposes accompanying rezoning, amendments to the General Plan and San Diego Municipal Code. A Program Environmental Impact Report (PEIR) was circulated for public review. A Draft PEIR along with the comments received during the public review period has been provided for review and consideration. [Report No. PC-22-050](#), [Attachments](#)
