#### CURRENT PLANNING COMMISSION DOCKETS AND BROWN ACT COMPLIANCE - COVID-19 PUBLIC SERVICE ANNOUNCEMENT REGARDING MEETING ACCESS AND PUBLIC COMMENT.

#### ITEM 1: Appeal of Hearing Officer decision on 11/16/2022 GATEWAY CANNABIS OUTLET – PROJECT NO. 1067659

**City Council District:** 9 **Plan Area**: Southeastern **Staff:** Travis Cleveland

Appeal of the Hearing Officer's November 16, 2022 decision to approve a Conditional Use Permit (CUP) for a new Cannabis Outlet in an existing 2,996-square-foot suite within an existing three-story, 42,530-square-foot commercial building located at 995 Gateway Center Way. The 4.10-acre site is in the IL-3-1 zone, the Airport Influence Area (San Diego International Airport, Review Area 1), and the High Fire Severity and Brush Management Zone within the Southeastern San Diego Community Plan and Council District 9. This project is within the scope of <u>Negative Declaration 660383</u>, adopted on August 18, 2021. This document adequately describes the activity for the purposes of CEQA. <u>Report No. PC-22-070</u>

#### ITEM 2: Continued from 10/27/2022 2022 UPDATE TO THE SAN DIEGO MUNICIPAL CODE AND LOCAL COASTAL PROGRAM

**City Council District:** All **Plan Area**: Citywide **Staff:** Liz Saidkhanian

The 84 items are separated into five categories; regulatory reforms, compliance with state law, corrections, clarifications, and amendments to align the code with the City's climate, equity, and housing goals. The topics of the amendments generally relate to the following areas of the Land Development Code: Housing and Housing Incentives, Sustainable Development Areas, Permit Procedures, Noticing, Development Impact Fees, Battery Energy Storage Facilities, Sea Level Rise Acknowledgements, Base Zone Regulations, Landscape Regulations, Historical Resources Regulations, Central Urbanized Planned District and the Downtown Planned District. The Environmental Policy Section of the Planning Department has reviewed the 2022 Update to the Land Development Code and the rezones and conducted a consistency evaluation pursuant to CEQA Guidelines Section 15162. Implementation of this project's actions would not result in new significant direct, indirect, or cumulative impacts over and above those disclosed in the previously certified documents listed in the Report to the Planning Commission <u>Report No. PC-22-052</u>, <u>Attachments 1-8</u>.
