#### HOW TO SPEAK TO A PARTICULAR ITEM DURING PUBLIC COMMENT:

<u>In Person for Agenda Items and Non-Agenda Public Comment:</u> Please fill out a speaker slip located at the entrance to the meeting. Indicate the item you wish to speak on as well as other requested information. Then submit it to the Chairperson at the box indicated near the speaker's lectern at the front of the room.

<u>Via Virtual Platform for Agenda Items and Non-Agenda Public Comment:</u> When the Chairperson introduces the item (or indicates it is time for Non-Agenda Public Comment), raise your hand by either tapping the "Raise Your Hand" button on your computer, tablet, or Smartphone, or by dialing \*9 on your phone. You will be taken in the order in which you raised your hand. You may only speak once on a particular item.

When the Chairperson indicates it is your turn to speak, unmute your phone by tapping the Unmute button on your computer, tablet or Smartphone, or dial \*6 on your phone.

**Please Note:** Members of the public who wish to provide virtual testimony must enter the virtual queue by raising their hand before the queue closes. The queue will close when the last virtual speaker finishes speaking or five minutes after in-person testimony ends, whichever happens first. **Those participating virtually may NOT cede time to others participating in person or virtually.**

# ITEM 1: \*BELLA MAR APARTMENTS - PROJECT NO. 631240

Staff: Martin Mendez City Council District: 8 Plan Area: Otay Mesa Nestor

The proposed project is a General Plan Amendment to re-designate the land use from Park, Open Space and Recreation to Residential; Community Plan Amendment to redesignate the land use from Open Space to Medium Density Residential (allowing up to 29 dwelling units per acre); Rezone from Agriculture-Residential (AR-1-2) and Open Space (OF-1-1) to Residential Multiple-Unit (RM-2-5); a Local Coastal Program Amendment to create consistency with the proposed Community Plan Amendment; a San Diego Municipal Code (SDMC) amendment to Chapter 13, Article 2, Division 4 to revise the Coastal Overlay Zone map to re-designate the site from Coastal Deferred Certification; and the adoption of a Mitigated Negative Declaration (MND) and Mitigation Monitoring and Reporting Program (MMRP), for the development of 380 multi-family dwelling units including 100 affordable dwelling units. The 14.62-acre site is located at 408 Hollister Street. The site is currently designated Park, Open Space and Recreation within the City of San Diego General Plan and designated as Open Space within the Otay Mesa-Nestor Community Plan; and zoned Agriculture-Residential (AR-1-2) and Open Space (OF-1-1) within the Otay Mesa-Nestor Community Planning area. The site is within the Coastal Overlay Zone (Deferred Certification), Parking Impact Overlay Zone (Coastal Impact), Airport Land Use Compatibility Overlay Zone [Brown Field, Naval Outlying Landing Field (NOFL) Imperial Beach, and Naval Air Station (NAS) North Island]. Mitigated Negative Declaration No. 631240. Report No. PC-23-001.

# ITEM 2: \*BDM MIXED USE PROJECT - PROJECT NO. 673818

**Staff:** Xavier Del Valle **City Council District:** 8 **Plan Area**: Otay Mesa

The proposed project is an affordable housing expedite project that includes a community plan amendment from Community Commercial – Residential Prohibited to Community Commercial – Residential Permitted, Rezone from CC-2-3 to CC-3-6, Vesting Tentative Map, Site Development Permit, Neighborhood Development Permit, Public Right-Of-Way Vacation and Public Service Easement Vacation to develop a mixed use development consisting of three to four level multi-family residential buildings with 430 dwelling units of which 52 dwelling units will be affordable to low income households with rents at 30% of 60% of the

Area Median Income, 6,000 square-feet of commercial uses, and associated site improvements on a vacant 13.44-acre site located south of Otay Mesa Road, east of Emerald Crest Court, southwest of Corporate Center Drive, and north of State Route 905 (APN No. 645-410-0300 to 645-410-0900) within the Otay Mesa Community Plan area. Addendum No. 673818 to the Otay Mesa Community Plan Update Final Program Environmental Impact Report has been prepared for the project in accordance with the California Environmental Quality Act. Report No. PC-23-010.
