# HOW TO SPEAK TO A PARTICULAR ITEM DURING PUBLIC COMMENT:

**In Person for Agenda Items and Non-Agenda Public Comment:** Please fill out a speaker slip located at the entrance to the meeting. Indicate the item you wish to speak on as well as other requested information. Then submit it to the Chairperson at the box indicated near the speaker's lectern at the front of the room.

<u>Via Virtual Platform for Agenda Items and Non-Agenda Public Comment:</u> When the Chairperson introduces the item (or indicates it is time for Non-Agenda Public Comment), raise your hand by either tapping the "Raise Your Hand" button on your computer, tablet, or Smartphone, or by dialing **\*9** on your phone. You will be taken in the order in which you raised your hand. You may only speak once on a particular item.

When the Chairperson indicates it is your turn to speak, unmute your phone by tapping the Unmute button on your computer, tablet or Smartphone, or dial **\*6** on your phone.

**Please Note:** Members of the public who wish to provide virtual testimony must enter the virtual queue by raising their hand before the queue closes. The queue will close when the last virtual speaker finishes speaking or five minutes after in-person testimony ends, whichever happens first. *Those participating virtually may NOT cede time to others participating in person or virtually.*

#### ITEM 1: HOUSING ACTION PACKAGE 2.0

**Staff:** Jeffrey Ryan **City Council District:** All **Plan Area**: Citywide

Homes for All of Us is a Citywide initiative aimed at producing more homes across the city that San Diegans of all income levels can afford. The Housing Action Package 2.0 includes regulations to implement the requirements of Senate Bill 10, which would allow for up to ten homes per lot in Sustainable Development Areas. The Housing Action Package 2.0 also includes amendments to the Land Development Code to implement state law to allow the construction of more new homes near transit, provide protections to existing residents and increase the supply of land available for new home development. This initiative will also incentivize and promote new home opportunities in all communities that San Diegans of all income levels can afford. The item includes amendments to the San Diego Municipal Code and the Local Coastal Program. <u>Report No. PC-23-009</u>

# ITEM 2: CANNABIS SOCIAL EQUITY AND ECONOMIC DEVELOPMENT ("SEED") PROGRAM UPDATES TO THE SAN DIEGO MUNICIPAL CODE AND THE LOCAL COASTAL PROGRAM - WORKSHOP

Staff: Tyler Sherer City Council District: All Plan Area: Citywide

This workshop will discuss proposed changes to the Land Development Code ("LDC") to implement the tools and regulatory compliance assistance that will help to eliminate some of the barriers to entry identified in the <u>City's Cannabis Equity Assessment</u>. The workshop will provide a public forum to solicit feedback on the proposed code changes which include:

1. Codifying Equity Assessment Chapter 7 SEED applicant and ownership criteria in the LDC.

2. Allowing 36 additional cannabis outlets for eligible SEED applicants and establishing a Cannabis Outlet SEED Overlay Zone (COSEED OZ) that includes a broad range of commercial zones within Transit Priority Areas (TPAs)

3. Reducing some of the strict sensitive use restrictions and distance requirements for new SEED cannabis outlets and production facilities and allowing SEED cannabis outlets as a Limited Use

4. Allowing SEED applicants to qualify for the program prior to securing a location.

5. Waiving or reducing licensing, permitting and inspection fees for SEED applicants.

6. Expanding cannabis outlet hours of operation in conformance with the state rules

7. Establishing a Cannabis SEED Incubator Program. <u>REPORT NO PC-23-023</u>, <u>Attachments 1-3</u> and <u>Attachments 4 -7</u>.
