**Via Virtual Platform for Agenda Items and Non-Agenda Public Comment:** When the Chairperson introduces the item (or indicates it is time for Non-Agenda Public Comment), raise your hand by either tapping the "Raise Your Hand" button on your computer, tablet, or Smartphone, or by dialing \*9 on your phone. **ITEM 1: *Appeal of Staff Decision on 4/25/2023***  
**735 NAUTILUS STREET – PROJECT NO. 693284**

**Staff:** Xavier Del Valle  
**City Council District:** 1  
**Plan Area:** La Jolla

A public hearing to consider an appeal of the Development Services Department approval of a Coastal Development Permit to demolish an existing single-family residence and construct two, new 3,121-square-foot single-family dwelling units with basements that will include a 310-square-foot accessory dwelling unit within each unit, and associated site improvements. The 0.15-acre site is located at 735 Nautilus Street in the RM-1-1 Zone, Coastal Overlay Zone (Non-Appealable Area), Coastal Height Limit Overlay Zone, and Transit Priority Area within the La Jolla Community Plan area. The project was determined to be categorically exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA State Guidelines Section 15303 (New Construction or Conversion of Small Structures). There were no appeals to the environmental determination. On April 25, 2023, the Development Services Department issued a Notice of Decision (NOD) approving the project, and on May 9, 2023, Harry Bubbins, President of the La Jolla Community Planning Association filed an appeal to the NOD citing that findings cannot be made. **HOUSING ACTION PACKAGE 2.0**

**City Council District:** All  
**Plan Area:** City Wide

Homes for All of Us is a Citywide initiative aimed at producing more homes across the city that San Diegans of all income levels can afford. The Housing Action Package 2.0 includes regulations to implement the requirements of Senate Bill 10, which would allow for up to ten homes per lot in Sustainable Development Areas. The Housing Action Package 2.0 also includes amendments to the Land Development Code to implement state law to allow the construction of more new homes near transit, provide protections to existing residents and increase the supply of land available for new home development. This initiative will also incentivize and promote new home opportunities in all communities that San Diegans of all income levels can afford. The item includes amendments to the San Diego Municipal Code and the Local Coastal Program.

**ITEM 3: T-MOBILE TROUT RESIDENCE (CUP) – PROJECT NO. 694722**

Conditional Use Permit for a Wireless Communication Facility (WCF) for the continued use of an existing facility consisting of two poles, 15 and 20-feet in height, supporting two antennas each for a total of four (4) antennas and equipment within an enclosure located in the rear yard of an existing residence. The site is located at 4030 Terrace Court in the RS-1-1 Zone of the Mid-City Kensington Talmadge Community Plan. The project was determined to be categorically exempt from the California Environmental Quality Act Section 15302 (Replacement) on March 8, 2023, and the opportunity to appeal that determination ended March 22, 2023.
