In Person for Agenda Items and Non-Agenda Public Comment:

Please fill out a speaker slip located at the entrance to the meeting. Indicate the item you wish to speak on as well as other requested information. Then submit it to the Chairperson at the box indicated near the speaker's lectern at the front of the room.

Via Virtual Platform for Agenda Items and Non-Agenda Public Comment:

When the Chairperson introduces the item (or indicates it is time for Non-Agenda Public Comment), raise your hand by either tapping the "Raise Your Hand" button on your computer, tablet, or Smartphone, or by dialing *9 on your phone. You will be taken in the order in which you raised your hand. You may only speak once on a particular item.

When the Chairperson indicates it is your turn to speak, unmute your phone by tapping the Unmute button on your computer, tablet or Smartphone, or dial *6 on your phone.

Please Note: Members of the public who wish to provide virtual testimony must enter the virtual queue by raising their hand before the queue closes. ITEM 1: Appeal of Process 2, staff decision on 7/19/2023 301 SPRUCE STREET - PROJECT NO. 1053621

> **Staff:** Robin MacCartee City Council District: 3 Plan Area: Uptown

The consideration of two appeals of a Neighborhood Development Permit (NDP) at 301 Spruce Street. The project would demolish five existing commercial-use structures with zero existing dwelling units on a four-lot parcel and construct a new 400,152-squarefoot, mixed-use structure including 262 dwelling units, 266 parking stalls, and 5,631 square-feet of commercial space with off-site utility work and sidewalks (project). The proposed project will be an "L" shaped building with building heights stepping up from 6 stories to 17 stories at 194 feet in height over four levels of subterranean parking and include a spa, co-working area, gym, community kitchen, dining area, pool, pool deck, BBQ deck, and reception area. The 0.81-acre site is in the RM-3-7 and CC-3-8 zones, Community Plan Implementation Overlay Zone (CPIOZ-A), the Complete Communities Housing Solutions Overlay Tier 2 FAR 8:0 and Tier 3 FAR 6.5, the Complete Communities Mobility Choices Mobility Zone 2 Overlay, Transit Area Overlay Zone (TAOZ), the Parking Standards Transit Priority Area (PSTPA), Transit Priority Area (TPA), Affordable Housing Parking Demand Medium Category, San Diego International Airport Influence Area Review Area 2, and the Federal Aviation Administration (FAA) Part 77 Noticing Area of the Uptown Community Plan area. The project is utilizing the Complete Communities Housing Solutions program. On July 7, 2023, the Development Services Department issued a Notice of Decision (NOD) approving the project. On July 18, 2023, The Uptown

Planners filed an appeal and on July 21, 2023, the Citizens Committed to Preserving Maple Canyon filed an appeal to the NOD.

The project was considered under CEQA Guidelines section 15162-consistency evaluation and determined that the proposed project was consistent with the previously certified Uptown Community Plan Update Program Environmental Impact Report (PEIR) (Project No. 380611/SCH No. 2016061023; certified by the City of San Diego City Council on September 15, 2016, Resolution No. R-310767) and the Final Environmental Impact Report for Complete Communities: Housing Solutions and Mobility Choices (SCH No. 2019060003) (May 2022). Report No. PC-23-035.

ITEM 2: *ALL PEOPLE'S CHURCH - PROJECT NO. 636444

Staff: Martha Blake **City Council District:** 7 **Plan Area**: Navajo

Community Plan Amendment, Planned Development Permit, Site Development Permit, Tentative Map, revestment of access rights and Easement Vacations (of slope, sewer, drainage, and utilities) to allow for the development of a 54,476-square-foot (SF) sanctuary/multi-purpose building, and a 71,010 SF, two-level parking garage (367 parking spaces), and would include a 900-seat (587 fixed seats) church plus accessory uses including Sunday school classrooms, offices, and a multipurpose room/gym. The 5.99-acre site is located at the northeast corner of Interstate 8 and College Avenue, within the RS-1-7 zone of the Navajo Community Planning area. Environmental Impact Report No. 636444/SCH No. 2021100394. Report No. PC-23-039.
