ITEM-2:* OLD TOWN SAN DIEGO COMMUNITY PLAN UPDATE - PROJECT NO. 561630City Council District:3Plan Area:Old Town San Diego

The Old Town San Diego Community Plan update is an update to the 1987 Old Town San Diego Community Plan, and includes a comprehensive update to the Old Town San Diego Planned District Ordinance and associated rezoning under the updated Planned District Ordinance. The draft Old Town San Diego Community Plan provides a comprehensive policy framework for growth and development over the next 20 to 30 years that is consistent with the goal of recreating the historical character of development in Old Town San Diego prior to 1872. Consistent with policy direction in the General Plan, the draft community plan proposes new land use designations, identifies opportunities for employment and transit-supportive residential densities within Transit Priority Areas, and contains policies to provide a multimodal transportation system fostering connections between community destinations and access to transit. The community plan update also incorporates architectural and urban design guidance currently found in the Old San Diego Architectural and Site Development Standards and Criteria into the Urban Design Element of the community plan, and updates and clarifies the architectural and urban design policies and requirements. A Program Environmental Impact Report (PEIR) has been prepared and circulated for public review. A Final PEIR along with the responses to comments has been completed and provided for review and consideration. Report No. PC-18-015.
