COMMISSIONER HOFMAN MADE THE MOTION TO APPROVE THE STAFF'S RECOMMENDATIONS TO RECOMMEND THAT THE CITY COUNCIL CERTIFY SUBSEQUENT ENVIRONMENTAL IMPACT REPORT NO. 417090/SCH NO. 1993121032, ADOPT THE FINDINGS AND STATEMENT OF OVERRIDING CONSIDERATIONS, AND ADOPT THE MITIGATION, MONITORING, AND REPORTING PROGRAM (MMRP); APPROVE CONDITIONAL USE PERMIT NO. 1605027 (AMENDING CONDITIONAL USE PERMIT/RESOURCE PROTECTION ORDINANCE NO. 92-0568) AND SITE DEVELOPMENT PERMIT NO. 1831047; APPROVE EASEMENT VACATIONS NOS. 1794303, 1794547, 1794552, 1807203, AND 1807207. Commissioner Austin seconded the motion. The motion passed by a vote of 5-0-2 with Commissioners Haase, Hofman, Austin, Granowitz and Otsuji voting yea and with Commissioner Whalen absent and with Commissioner Peerson recusing.
