#### POLICE STAFF REPORT:

Assistant Chief Jarvis update RIPA requirements. Over 100,000 contacts as of last week. SDPD invited to attend RIPA meeting in Oakland to report to law enforcement agencies statewide.

Captain Bollard from Central Division. Been on assignment for 10 months. Monthly Community Walk was suspended for a few months but back on schedule. He holds Captain's Advisory Board meetings and is open to the public. Patrol Officer Walsh is retiring after 29 years. Has 7 out of 20 FTO positions unfilled.

What works well?

- Hiring officers to come work at Central Division.
- Has two CRO's with experience as patrol officers.
- Homeless outreach coordination with Neighborhood Policing Division.

What doesn't work well?

- Needs more officers. They have fewer than before.
- Challenge of homeless population growing.
- Challenge of number of demonstrations (almost daily).
- Alcohol and drug abuse in the Gaslamp District.
