Recommend to SDPD that when any branch of the San Diego Police Department ("SDPD") shares evidence with the San Diego Medical Examiner's Office ("ME") regarding an in-custody death or officerinvolved shooting, SDPD must thoroughly document in writing each piece of evidence shared with the ME, including, but not limited to, Body Worn Camera ("BWC") footage. SDPD should document the date and time the evidence is shared, the title of the evidence, who it was shared by, whom it was shared with, whether the ME retained the evidence, and in the case of BWC footage, the date and time the video was shown, the title of each video clip shown, whether each video was viewed in its entirety, and the names of everyone (including SDPD personnel) who viewed the video(s). This information must become part of the Internal Affairs file and must be available for Community Review Board members to review.
