OVERVIEW:

To address the inequities in the City's park system, on August 3, 2021, the City Council adopted the Parks for All of Us initiative, which included the Parks Master Plan, an amendment to the General Plan Recreation Element, an updated Citywide Park Development Impact Fee to replace all current community planning area—based existing park impact fees, and the designation of the Chollas Creek Watershed as a Regional Park. Parks for All of Us is focused on addressing park system inequities so that everyone has access to safe, clean, and thriving park spaces. Under Parks for All of Us, park investments are prioritized in the areas where the needs are the greatest.

The City Council motion to adopt the Parks for All of Us initiative included a request for a presentation on the timing for the Parks for All of Us implementation items. This staff report describes the progress that the Planning and Parks and Recreation Departments have jointly made to date and outlines planned and needed future steps to achieve the Parks for All of Us vision.

PROPOSED ACTIONS:

No action required; this item is informational.

DISCUSSION:

The 2008 General Plan identified the need for a new Parks Master Plan. The last Parks Master Plan was approved in 1956, when San Diego was considerably smaller and less diverse. On August 3, 2021, the City Council adopted the Parks for All of Us initiative, which included a new Parks Master Plan ("Plan") focused on addressing inequities in the City's park system. The Parks for All of Us initiative also included an amendment to the General Plan Recreation Element, the adoption of an updated Citywide Park Development Impact Fee, as well as the formal designation of the Chollas Creek Watershed as a Regional

Park. At the City Council hearing, the motion to approve Parks for All of Us included a request to return to City Council to provide an update on future implementation, including projected timelines and a prioritized list of actions.

With the adoption of Parks for All of Us, the City's focus has shifted to implementing the Parks Master Plan's vision in accordance with the Plan's future implementation framework. The complete realization of the Plan's vision will take many years of concerted and collaborative effort between park stakeholders, members of the public, and various City departments. While this effort will require additional budgetary and staffing resources, staff is excited to have taken the first steps to implement the Plan. The table below identifies each of the prioritized implementation action items identified in the Plan, including projected timelines. As noted below, completion of each of these tasks is contingent upon future staffing and budget levels for both the Planning and Parks and Recreation Departments. With appropriate staffing and funding in the coming budget years, the Departments are committed to implementing this important and landmark Plan.

Climate Action Plan Strategies:

The Parks Master Plan Implementation Framework includes various projects which helps the City meet its CAP targets, specifically the framework address strategy 3 and 5 directly. The development and implementation of a Citywide Trails Master Plan will lead to a larger more diverse trail system enabling residents to use the trail network to commute. The expanded trail networks will contribute to the City's CAP goal of achieve a walking commuter mode share of 4% by 2020 and 7% by 2035 in Transit Priority Areas.

The Chollas Creek Watershed Regional Park Master Plan and any updates to resource-based regional park master plans will be guided by the recently adopted Parks Master Plan, a plan that includes policies aimed at increasing and expanding the City's urban tree canopy. These regional park master plans will help the City meet its CAP goal of 35% urban tree coverage by 2035.

Previous Council and/or Committee Actions:

On July 14, 2021, the Public Safety and Livable Neighborhoods City Council Committee voted unanimously to recommend adoption of Parks for All of Us with amendments.

On August 3, 2021, The City of San Diego City Council heard the Parks for All of Us initiative and voted 8 to 1 to:

Adopt a resolution (R-313685) adopting the Addendum to Environmental Impact Report No. 104495/SCH No. 2006091032, which was finalized on May 8, 2020, and adopting the Mitigation, Monitoring, and Reporting Program.

Adopt a resolution (R-313686) approving an amendment to the General Plan Recreation Element.

Adopt a resolution (R-313687) adopting the City of San Diego Parks Master Plan.

Adopt a resolution (R-313688) adopting a Citywide Park Development Impact Fee to update and replace the existing park component of Community Planning Area-based Development Impact Fees, including a 5 percent administrative fee.

And introduce an ordinance designating the Chollas Creek Watershed as a San Diego Regional Park pursuant to San Diego Charter Section 55.2(a)(9).

On September 14, 2021, the City of San Diego City Council voted 8 to 1 to adopt the Ordinance (O-21372) designating Chollas Creek Watershed as a San Diego Regional Park pursuant to San Diego Charter Section 55.2(a)(9) which was introduced on 8/03/2021.

Key Stakeholders and Community Outreach Efforts:

The Planning Department, along with the Parks and Recreation Department, has conducted major public input activities as part of the Parks for all of Us initiative. The public input activities included workshops, online engagement activities, pop-up community events, a statistically valid survey, and stakeholder outreach. These activities were used to inform the Parks for all of Us implementation framework.
